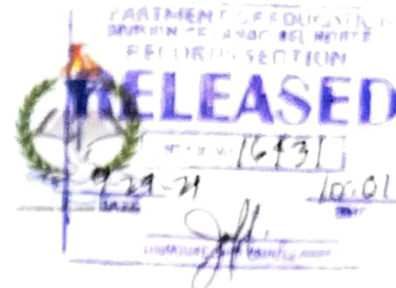

SUBJECT : **2021 PROVINCIAL VIRTUAL MEET AND SPORTS SKILLS DEMONSTRATION CONTEST**

DATE : **23 SEPTEMBER 2021**

1. In reference to OUA Memo 00-0821-0060 dated August 9, 2021 and Regional Memorandum No. 503, s. 2021 dated September 7, 2021 titled **DepEd Sports Skills Demonstration Contest**, this Office, through the School Governance & Operations Division, will conduct the **First Provincial Virtual Meet and Sports Skills Demonstration Contest** on November 10-12, 2021.
2. The primary objective of the said virtual activity is to provide the public school student-athletes with an opportunity and alternative venue to showcase their athletic talents and skills in the absence of an organized school-based sports tournament due to the effects of the nationwide COVID-19 pandemic.
3. Each municipality/district is encouraged to participate in at least one sports event.
4. Attached are the guidelines and mechanics of the competition for references, guidance and information.
5. Immediate dissemination and strict compliance of this Memorandum is desired.

General Information in the Conduct of Sports Event for Skills Demonstration Contest

1. The sports skills and talent demonstration contest shall be known as "DepEd Sports Skills Demonstration Contest";
2. The contest shall be open to public high schools only presently having a varsity team/sports club whose athletes are currently enrolled in calendar school year (SY) 2021-2022;
3. Participants to the Contest shall be a group comprising a minimum of six and maximum of 12 members;
4. The Contest shall commence with a district competition, in which the winners will compete as qualifiers to the division level competition;
5. The Provincial Virtual Finals shall be managed and supervised by the personnel of School Governance & Operations Division;
6. To comply with the restrictions set by the IATF, particularly in the conduct of various sports activities, the Contest shall be conducted virtually. The participating groups shall submit a recorded entry of their performance based on the requirements set in the guidelines for submission of entries;
7. The School/District Sports Officer is primarily responsible in identifying and selecting participating student-athletes, that would be in the best position to form, prepare, and train a group and exhibit the sports skills/talent demonstration piece;
8. All secondary schools and central elementary schools are allowed to enter or field a maximum of five (5) groups that will showcase distinct sports performances to the division competition. As an example, the first team may exhibit taekwondo skills, while the other teams may exhibit basketball dribbling skills, arnis synchronized skills, volleyball tossing skills, and gymnastics skills. While all elementary schools may have at least one (1) group choosing any of the sports event mentioned;
9. Participating schools shall observe at all times the prevailing risk level classification of its locality and the guidelines being enforced in accordance with latest Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines so as to be properly guided on the decision and course of action to be undertaken in managing the team on its conduct of activities such as meeting, training, rehearsal, taping and among others;
10. Decision of the judges are final. Protest shall not be entertained;

A. Contest Format

In compliance with the IATF rules prohibiting the conduct of social gatherings and face-to-face activities, the administration of the District Contest and the Division Finals shall be via the online modality.

- District Contest – The district organizing/Technical Working Committee shall be given full discretion as to the contest format it will adopt depending on the number of entries submitted. For municipalities with voluminous number of entries, particularly those consisting of many schools, it may conduct a qualifying or elimination round prior to the finals of its District Contest. The winners of the District Contests shall be automatically declared as finalists to the Division Finals.
- Division Finals – The format of the Division Finals shall be a single round performance of all the district finalists, which will be judged by five (5) members of the board of judges based on the criteria set in these guidelines. The district/municipality with the best performance of sports skills shall be declared champion while there shall also be runners-up of up to 4th place.

B. Entries

1. Entries containing the performances of teams shall be **recorded**;
2. Performances shall be done within **two (2) to three (3) minutes** time limit;
3. Performances shall be accompanied by **any genre of music** or any **musical instrument of choice** as background;
4. Wearing of **appropriate attire/uniform/costume** is encouraged;
5. Use of **stage props, or any paraphernalia and/or apparatus** shall be allowed provided it will not cause any harm or accident during the performance; and
6. **Stunts and other forms of acrobatics such as pyramids, lifts, throws, among others** that will cause any harm or accident during the performance are **highly discouraged**.

. Venue

1. The school gym/stage or any venue or hall that has space wide enough and free from any protruding objects and posing no danger may be utilized by the participating teams as their venue for training or rehearsals, and actual shooting or recording of their entry;
2. The venue shall comply with the existing guidelines on the current risk level category being enforced by its local IATF;
3. The size of the performing stage floor or area is **10 meters x 10 meters** (width x length);
4. The floor surface must be smooth and without protruding objects, and if possible, it must be covered with any material that would be safe for the athletes to perform their movement such as puzzle mats or wrestling mats;
5. Venue lighting system should be sufficient to support the production of a high-resolution video of the performance that will clearly exhibit the routine or movement of the team; and

Judging

1. For the Final Contest, there shall be a Board of Judges composed of five (5) members. One member shall be appointed by the division office as the Head of the Board of Judges;
2. All entries shall be evaluated using an **online scoring system** to be developed by the Organizing/Technical Working Committee;
3. Prior to the start of the contest, a drawing of lot shall be conducted to determine the order of the presentation of the **video recorded** performance of the participating teams;
4. Each judge shall independently record his/her score on every performance. Judges' score shall then be forwarded to the Head of the Board of Judges for his/her validation of the final score earned;
5. The team that earned the highest score shall be declared the champion; and
6. Should there be a tie in the scores, the Board of Judges shall convene in a separate conference room to review the entries if necessary, and discuss, deliberate, and come up with a collegial decision and determine the winner.

IV. COVID-19 Risk Mitigating Measures

1. In compliance to DepEd Order No. 14, s. 2020 entitled *Guidelines on the Required Health Standards in Basic Education Offices and Schools*, the schools shall observe the COVID-19 risk mitigating measures during the training, rehearsals, and shooting of team's performance;
2. The school and the participating team should be aware of the current policies and guidelines on community quarantine being enforced by their local government unit; and
3. Participants shall be reminded at all times to observe the minimum health standards and safety protocols.
