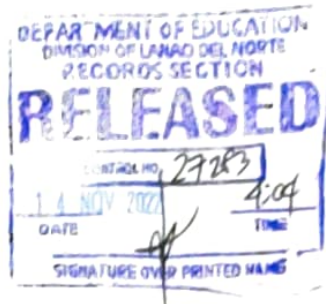

**ADDITIONAL GUIDELINES IN THE CONDUCT OF  
DIVISION-WIDE READ-A-THON ACTIVITIES IN CELEBRATION  
OF THE NATIONAL READING MONTH**

1. Participants shall be at the venue at 7:30 am for the preliminaries.
2. Only District 1<sup>st</sup> place winners per category are qualified to join the contest in the Division Level. In case the 1<sup>st</sup> place winner is unable to participate, the 2<sup>nd</sup> placer may represent the district.
3. Participants of the different contest categories are encouraged to wear their school uniform during the contest. However, this is not compulsory.  
STRICTLY NO COACHING SHALL BE OBSERVED WHILE THE CONTEST/PRESENTATION IS GOING ON.
4. All winners will receive medals and certificates of recognition while the non-winners will be given certificates of participation.
5. The panel of judges shall be composed of a chairman and three members.
6. The decision of the board of judges is final and irrevocable.
7. The District Reading Coordinator shall submit the District Entry Form following the format below.
8. Wearing of face masks, proper hand washing and social distancing shall be observed during the entire competition.
