5th DIVISION FESTIVAL OF TALENTS (DFOT) 2021-SINING TANGHALAN

- 1. The 5th Division Festival of Talents (DFOT)-Sining Tanghalan 2021 shall be conducted on November 29, 2021, 7:30 in the morning at Maranding Central Elementary School and Lala National High School, Maranding, Lala, Lanao del Norte, with the theme: "Demonstrating Resiliency of Learners During Covid 19 Pandemic through Showcasing of Skills and Talents in the Culture and the Art, and Technology".
- 2. The competition aims to:
 - raise awareness of the people on culture and the arts through competition;
 - b. provide opportunities for learners to showcase their talents and skills through exhibition of their products, services and performances; and
 - c. prepare learners for work or higher learning.
- 3. The events to be contested are the following:
 - Folk Dance Contest (Elementary)-Virtual
 - Likhawitan (Secondary)
 - Pintahusay (Secondary)
 - On the Spot Painting Contest (Elementary)
 - Awiting Bayan Kundiman Competition (Elementary)
 - Hip-Hip Dance (Secondary)-Virtual

- 4. Participants to the said competition are Education Program Supervisors, Public District Supervisors, MAPEH Lead Principals, Contest Facilitators and the **First Place Winners** during the District MAPEH Festival of Talents.
- 5. Participating schools are responsible for the contest materials, meals and snacks needed during the competition.
- 6. During the competition, the board of judges and facilitators shall report to the venue specified in this memorandum per event to ensure that technical problems that may possibly occur will be addressed immediately.
- Solidarity Meeting of MAPEH lead administrators, secondary coordinators, contest facilitators, coaches and Technical Working Group will be on November 4, 2021 at Lala National High School Open Gym, Maranding, Lala, Lanao del Norte at 8:00 in the morning.
- 8. The concerned participants and facilitators are encouraged to observe proper health and safety protocols instituted by the Inter-Agency Task Force (IATF) such as wearing of face mask, face shield and observance of social distancing during the conduct of the training simulation and training proper.
- Enclosed are the copies of the guidelines and mechanics, contest events, dance literature, list of judges, facilitators and working committee for reference.
- 10. Traveling expenses and meals of the participants shall be charged against school MOOE/local funds subject to the usual accounting and auditing rules and regulations.
- 11. Immediate dissemination of and strict compliance with this Memorandum by all concerned is highly enjoined.

Guidelines/Mechanics and Criteria for the 2021 Division Festival of Talents

1. Virtual: Folk Dance Contest- Elementary

- A maximum of 6 dancers (3 Pairs) and 1 coach will be allowed per district.
- Only one (1) entry per district.
- Maximum of 5 minutes. In dances where the literature does not specify or describe the entrance/exit, the trainer may arrange one, however, both must not exceed sixteen (16) measures.

Venue: Lala National HS

- The contest piece is a rural folk dance entitled, "REGATONES" with implement highlighting occupational activities.
- The dance must be **Video** recorded using any device (phone, tablet, camera) available to the eligible contestant.
- Video must be submitted in one, uninterrupted and continuous take. No Editing
 of Video is allowed and no special effect can be applied. Any edited video
 will be disqualified.
- Cameras must remain stationary for the complete recording of the video, "No zooming in" or "zooming out". This is to ensure that the judges can view the entirety of the performance.
- All videos should be filmed in landscape and submitted in an **MP4** formats thru **google drive** with complete name of the district.
- Medley (combination) of different dances is not allowed
- One (1) point deduction from each judge's total score shall be deducted for every 30-second extension beyond allowable time.
- The decision of the board of judges once announce is final and irrevocable.
- Violation of the above-mentioned guidelines will result in disqualification.

2. Likhawitan

Venue: Maranding Central ES

(6 hours songwriting and 3-5 minutes performance) Secondary Only

- Only 1 entry is allowed per secondary school.
- Only 4 student participants per group/secondary school accompanied by 1 coach is allowed. Only two (2) students will perform-1 solo singer and 1

- accompanist (acoustic guitar). The other two (2) will help in the composition writing.
- Song must be written in Filipino or in English and they may choose any type of genre (ballad, rock, etc.) for his or her composition
- Each group will be given 6 hours to compose the song based on the theme: "Demonstrating Resiliency of Learners During Covid 19 Pandemic through Showcasing of Skills and Talents in the Culture and the Art, and Technology".
- The handwritten **notated** composition with the lyrics and chords must be submitted to the contest administrators after the allotted time.
- The contestants are allowed to use acoustic guitar in aide to song writing composition.
- Song performance must not exceed **5 minutes** including entrance and exit. A one (1) point deduction from the general average score of each judge shall be made for every 30-second extension.
- Participants shall wear their own school uniforms.
- Contestant is not allowed to go out once the contest started.
- No props will be allowed during the performance.
- Participants must come on time thus late contestants will no longer be entertained.
- The First Place winners shall represent the division to the Regional Festival of Talents 2021.

 - Student-Participants are responsible for the provision of their own materials.
 Materials to be used: Paintbrushes, Sponges, Paint Container, and Paint Cleaning, Acrylic Paint 1
 Liter per Color (Blue, Red, Yellow and neutral colors (white and black), Canvass (36 X 48 inches) with frame painting easels, Tripod Stand (for the canvass).

- The subject of the painting will be based on a theme which will be given during the event.
- Student Participants are not allowed to bring pictures or images for reference of their entries.
- The First Place winners shall represent the division to the Regional Festival of Talents 2019.

6. Virtual: Hip-Hop Dance Contest (Secondary)

Venue: Lala National HS

- Minimum of 6 and a maximum of 8 learners regardless of gender
- There can be one (1) team per secondary school.
- Music can be remixed and performance should not exceed to three (3) minutes and thirty (30) seconds (3:30) including entrance and exit. A deduction of one (1) point from the total score for every excess of second shall be applied.
- The use of pyrotechnics, flammable materials, deadly weapons, dangerous stunts like pyramids and double backflips are strictly prohibited. Any violation to the guidelines will be subject to disqualification from the contest.
- Any kind of hip hop dance is allowed (krumping, breakdance, locking, popping, waacking, etc.) or any kind of dance with hip hop as their focal thought of choreography provided that the choreographer/coach of the team have the proper knowledge or background to execute it properly.
- The dance must be **Video** recorded using any device (phone, tablet, camera) available to the eligible contestant.
- Video must be submitted in one, uninterrupted and continuous take. No Editing of Video is allowed and no special effect can be applied. Any edited video will be disqualified.
- Cameras must remain stationary for the complete recording of the video, "No zooming in" or "zooming out". This is to ensure that the judges can view the entirety of the performance.
- All videos should be filmed in landscape and submitted in an MP4 formats thru google drive with complete name of the district.
- One (1) point deduction from each judge's total score shall be deducted for every 30second extension beyond allowable time.
- The decision of the board of judges once announce is final and irrevocable.
- Violation of the above-mentioned guidelines will result in disqualification.
