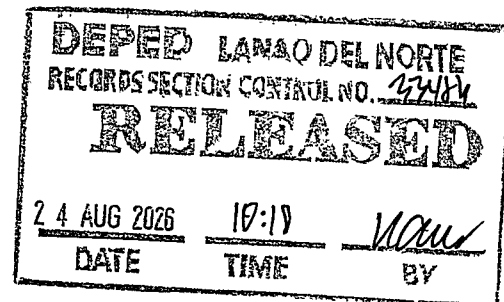

1. In view of the Boy Scouts of the Philippines (BSP) Mindanao Regional Memorandum No. 1, s 2026 re: **7th One Mindanao Scout Jamboree**, all concerned schools in this Division are hereby informed of the conduct of the said activity on September 3-6, 2026 at BSP Camp Obedencia, Pendulonan, Lala, Lanao del Norte.

2. School Heads are advised to facilitate the participation of their registered BSP in the aforementioned activity on a **voluntary basis**. As such, participants shall shoulder any participation fee/s and travel/incidental expenses to be incurred during the jamboree.

3. Participation to this activity shall be subject to the no-disruption-of-classes policy as stipulated in DepEd Order No. 9, s.2005 titled Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance therewith, Section 3 of Republic Act No. 5546 (Policy Contributions), and DepEd Order No. 66, s.2017 (Policy on Off-Campus Activities). Thus, interested school heads and personnel are advised to make necessary arrangements in their respective stations regarding their designated tasks

and responsibilities so as not to disrupt the delivery of services to students and to our DepEd clientele. All participants shall submit to this Office a work plan on school days affected by the activity which is to be attached with the participants' letter of intent in joining the said activity. Furthermore, student participants are required to submit parental consent prior to the said activity.

SUBJECT : 7TH ONE MINDANAO SCOUT JAMBOREE

1. Pursuant to the 2026 Approved Regional Calendar of Scouting Observances, Events, Activities, and Training, we are pleased to announce the conduct of the **7th ONE MINDANAO SCOUT JAMBOREE** on **03-06 September 2026** at BSP Camp Obedencia, Pendulonan, Lala, Lanao del Norte, hosted by the Lanao del Norte Council with the theme: "Uniting a Stronger Scouting in Mindanao".
2. The Jamboree aims to provide a progressive, safe, and enjoyable learning environment for Scouts in order to enhance their physical, social, mental, emotional, and spiritual potential.
3. **QUALIFICATIONS FOR PARTICIPATION**
 - a. **SCOUT** is expected to have leadership potential, sufficient camping experience, and be physically fit to undergo strenuous activities with the corresponding parental consent and:
 - i. Must be currently registered Boy Scout or Senior Scout;
 - ii. Must be at age of 12 to 17 years old; and
 - iii. Must be equipped with camping gears.
 - b. **ADULT LEADER.** Should have maturity and clarity of his role, and:
 - i. Must be currently registered;
 - ii. Must be physically fit as certified by a physician;
 - iii. Must be of good moral character and must be equipped with camping gear;
 - iv. Must be at least a graduate of Basic Training Course (BTC); and
 - v. Must have completed the Safe from Harm 1 Course.
 - c. **MINDANAO SERVICE TEAM (MST).**
 - i. Must be currently registered as an Adult Leader aged between 18 to 55 years old;
 - ii. Must be physically fit as certified by a physician;
 - iii. Must be of good moral character;
 - iv. Must be at least a Wood Badge Holder and must have served as a National/Regional/Council Service Team in any Scouts Jamboree;
 - v. Must have completed the Safe from Harm 1 & Safe from Harm 2 Courses; and
 - vi. Must be duly recommended by the Council Scout Executive/Officer-in-Charge.

4. **Registration Fee.** A registration fee of **ONE THOUSAND PESOS ONLY (P1,000.00)** shall be charged from each participant and MST to defray expenses for program materials, certificates, individual souvenir items (Neckerchief, Patch, ID with Lanyard, and T-shirt), camp development, meals of the Jambo Staff/MSTs and other related administrative costs during the event.

Remittance and deposit of the registration fees shall be done in **bulk ONLY** by the authorized Council Staff of their respective Local Council. **NO individual deposit** shall be allowed to properly account for the total registrants per council. Please see the bank details below:

NO ON-SITE registration shall be allowed. Registration fees are non-refundable but may be transferred to another participant. Deadline of registration fee is on 31 July 2026.

Participation of the Adult Leaders and members of the MST is further requested to be on **OFFICIAL BUSINESS.**

5. **Participant Ratio.** To exercise effective and efficient unit organization and management, a ratio of **one (1) Adult Leader** for every **nine (9) Boy/Senior Scouts (1:9)** must be observed in the composition of the Jamboree Contingent.

Furthermore, each Local Council is allowed to send a **maximum of TEN (10)** applicants for the Mindanao Service Team. **Application for the MST** should reach the corresponding Regional Coordination Office **on or before 15 July 2026.**

6. **EQUIPMENTS AND FOOD PROVISIONS.** Each contingent is required to provide their own camping equipment and gadgets. Other basic requirements and food provisions sufficient for the entire duration of the event should also be the responsibility of each contingent.

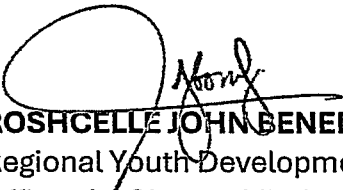
