ADDENDUM TO SPECIAL ORDER NO. 142, S. 2025 OBSERVANCE OF FLEXIBLE WORKING HOURS FOR MUSLIM TEACHING AND NON-TEACHING PERSONNEL DURING THE HOLY MONTH OF RAMADAN

- 1. In reference to **DepEd Memorandum No. 020, 2025**, particularly Item 5, which encourages the observance of Alternative Delivery Modes (ADM) only during the last ten (10) days of Ramadan, the following provisions are hereby added to **Division Memorandum No. 142, s. 2025**:
 - a. **Implementation of ADMs** Schools are encouraged to observe ADMs exclusively during the last ten (10) days of Ramadan for both personnel and learners, as per Item 5 of DepEd Memorandum No. 020, s. 2025. This shall allow Muslim learners to focus on religious observance while ensuring the continuity of learning.
 - b. Orientation of Stakeholders in line with Item 6 of the said memorandum, schools shall conduct an Orientation for Muslim parents and learners regarding the use of ADMs during the last ten (10) days of Ramadan. This aims to provide clear guidelines on the implementation and expectations of ADM to ensure a smooth learning process.
 - c. Monitoring of ADMs school heads shall ensure the proper monitoring of ADM implementation during the last ten (10) days of Ramadan. They are tasked with overseeing the effectiveness of ADM strategies, ensuring accountability, and addressing any concerns that may arise in the process.
