ADHERENCE TO THE IMPLEMENTATION OF EXECUTIVE ORDER

NO. 14, S. 2020 OF THE PROVINCIAL GOVERNMENT OF LANAO DEL NORTE

DATE: June 4, 2020

- 1. Relative to the DepEd Order No. 007, s. 2020 dated May 11, 2020, teachers shall render 1st day of service on June 1, 2020 while DepEd Memorandum No. 54, s. 2020 dated May 29, 2020 states that teachers shall not report physically to school on June 1-5, 2020. It is understood that reporting to school physically shall commence in the succeeding weeks unless intervened by another DepEd issuance.
- 2. Relative to this, to ensure health and safety while on travel from residence to school/office and vice-versa, this Office directs all teaching and non-teaching personnel to strictly adhere to Executive Order No. 14, s. 2020 (attached) with emphasis on Section 5 Public and **Private Transportation** which states that:
 - **Public Transportation** 1.
 - a. Public Utility buses
 - i. 50% of the vehicle capacity excluding the driver and conductor
 - ii. No standing passengers
 - iii. Strict one(1) meter distance between passengers or shall be seated one seat apart
 - b. Public utility vans
 - i. 50% vehicle capacity excluding the driver

- ii. Strict one(1) meter distance between passengers or shall be seated one seat apart
- c. Tricycles
 - i. Maximum of one passenger in the side case
 - ii. No passenger shall be seated behind the driver
- II. Private transportation
 - a. Sedan Cars
 - i. Only four (4) persons are allowed inside the vehicle including the driver
 - ii. Passengers shall be seated one (1) seat apart
 - b. SUVs and Vans
 - i. 50% capacity of the vehicle capacity excluding the driver
 - ii. Strict one(1) meter distance between passengers or shall be seated one seat apart
 - c. Motorcycles
 - Only one (1) back ride is allowed provided, that the passenger shall wear helmet, mask, gloves and jacket or long sleeves and provided further, that motorcycles operating as Habal-habal shall not be allowed to operate in national highways.

- 4. Strict compliance of this Memorandum is directed.

EXECUTIVE ORDER NO. 14 SERIES OF 2020

"AN EXECUTIVE ORDER PROVIDING FOR THE GUIDELINES ON THE DECLARATION OF MODIFIED GENERAL COMMUNITY QUARANTINE (MGCQ) IN THE ENTIRE PROVINCE OF LANAO DEL NORTE AND FOR OTHER PURPOSES".

WHEREAS, on 22 March 2020, the Province of Lanao del Norte was placed under ENHANCED COMMUNITY QUARANTINE to prevent the spread of the COVID-19;

WHEREAS, on 24 April 2020, the National Inter-Agency Taskforce for the Management of Emerging Infectious Disease categorized the Province of Lanao del Norte as Moderate Risk (Orange) considering the low number of Probable, Suspect and Confirmed cases of COVID-19 in the Province and has directed the transition from Enhanced Community Quarantine to General Community Quarantine;

WHEREAS, on 30 April 2020, the National Inter-Agency Task Force for the Management of Emerging Infectious Disease issued Resolution No. 30, Series of 2020 providing for the Omnibus Guidelines on General Community Quarantine (GCQ);

WHEREAS, on 3 May 2020, Executive Order No. 8 Series of 2020 was issued placing the entire Province of Lanao del Norte under GENERAL COMMUNITY QUARANTINE in order to open essential businesses to restart the economy but various protocols were maintained to ensure the safety of the people of Lanao del Norte;

WHEREAS, on 13 May 2020, the National Inter-Agency Taskforce for the Management of Emerging Infectious Diseases issued Resolution No. 35-A categorizing the Province of Lanao del Norte as Low Risk and has directed that it stays under the GENERAL COMMUNITY QUARANTINE;

WHEREAS, on 27 May 2020, the Province of Lanao del Norte has maintained its status of being a Low Risk under Resolution No. 40 issued by the National Inter-Agency Taskforce for the Management of Emerging Infectious Diseases and was directed to transition from GENERAL COMMUNITY QUARANTINE (GCQ) to MODIFIED GENERAL COMMUNITY QUARANTINE (MGCQ);

WHEREAS, Section 465 (b) vii of Republic Act 7160 otherwise known as The Local Government Code of 1991 authorizes the Provincial Governor to carry out emergency measures as may be necessary during and in the aftermath of man-made and natural disasters;

WHEREAS, there is a need to provide guidelines in consonance to the national government and the National Inter-Agency Taskforce for the Management of Emerging Infectious Disease policies to safeguard the health and safety of the people and to prevent the corona virus from spreading in the province;

NOW THEREFORE, I, IMELDA QUIBRANZA DIMAPORO, Provincial Governor of the Province of Lanao del Norte, by virtue of the power vested in me by the Local Government Code of 1991 and other pertinent laws of the Republic of the Philippines, do

hereby direct and Order:

SECTION 1. WORK ARRANGEMENT. Work in government offices maybe at full operating capacity, with alternative work arrangements for persons who are sixty (60) years old and above, those with immunodeficiency, comorbidity or other health risks and pregnant women.

Work in the Provincial Government of Lanao del Norte shall now be at full operating capacity even during the period of the Modified General Community Quarantine (MGCQ) and shall follow the mandatory working hours in government offices.

SECTION 2. CLASSES IN PRIVATE AND PUBLIC SCHOOLS. Resumption of Classes in Private and Public schools shall depend on the directives of the National Government and the guidelines to be provided by the Commission on higher Education (CHED), Department of Education (DepEd), Technical Education and Skills Development Authority (TESDA) and other regulatory agencies, however, other school activities shall remain suspended.

SECTION 3. All businesses or sectors in the province are allowed to operate at full operational capacity except the following:

- Barber shops, Salons, Massage Parlors, Spas and other personal care service establishments shall operate at a maximum of fifty percent (50%) venue capacity.
- b. Food retail establishments shall be allowed to operate but DINE-IN shall be limited to fifty percent (50%) of the venue or seating capacity of the establishment.
- c. Internet cafés/Computer shops, Resto Bars, Videoke Bars, Fitness Gyms, betting establishments, Swimming Pools and Beach Resorts shall remain closed.
- d. Gambling is still prohibited, establishments that are operating billiards and sabong shall remain closed.
- e. No Hotels, Apartels, Motel and Lodges shall be allowed to operate.
- The respective managements of businesses that are opened shall ensure that wearing of face masks and strict physical distancing measures are observed.
- The disinfection of workplaces shall also be implemented.
- •All health protocols, guidelines and policies of the DOH shall also be observed.

SECTION 4. RESUMPTION OF ALL PUBLIC AND PRIVATE CONSTRUCTION PROJECTS. All public and private construction projects shall be allowed to resume subject to strict compliance with the construction safety guidelines issued by the DPWH for the implementation of infrastructure projects during the COVID-19 Pandemic. For construction projects implemented by the Provincial Government and the Municipal Local Government Units the following guidelines shall be observed:

- All workers must strictly observe appropriate physical distancing.
- b. All workers are required to use facemasks, ear loop masks, reusable, do-it-yourself masks, face shields, handkerchiefs or such other protective equipment or a combination thereof, which can effectively lessen the transmission of COVID-19.
- c. For workers whose residence is outside the Province of Lanao del Norte, the employer/contractor is required to establish a bunkhouse where these workers can temporarily live.

SECTION 5. PUBLIC AND PRIVATE TRANSPORTATION. The road, rail, maritime and aviation sectors shall be allowed to operate at the capacity in accordance with the guidelines issued by the DOTR.

- I. For public transportation, the following guidelines shall be observed:
 - a. Public Utility Buses
 - -50% of the vehicle capacity excluding the driver and conductor.
 - No standing passengers.
 - -Strict one (1) meter distance between passengers or shall be seated one seat apart.
 - b. Public Utility Vans
 - -50% of the vehicle capacity excluding the driver.
 - -Strict one (1) meter distance between passengers or shall be seated one seat apart
 - c. Tricycles
 - -Maximum of one (1) passenger in the side case.
 - -No passenger shall be seated behind the driver.
- II. For private transportation the following guidelines shall be observed:
 - a. Sedan Cars
 - -only four (4) persons are allowed inside the vehicle including the driver.
 - -passengers shall be seated one seat apart.
 - b. SUVs and Vans
 - -50% of the vehicle capacity excluding the driver.
 - -Strict one (1) meter distance between passengers or shall be seated one seat apart
 - c. Motorcycles

-only one (1) back ride is allowed provided, that the passenger shall wear helmet, mask, gloves and jacket or long sleeves and provided further, that motorcycles operating as Habal-Habal shall not be allowed to operate in national highways.

SECTION 6. MASS GATHERINGS. Mass gatherings such as but not limited to, movie screenings, concerts, other entertainment activities, community assemblies and non-essential work gatherings shall be allowed provided that participants shall be limited to fifty (50%) percent of the venue or seating capacity.

Religious gatherings shall be allowed to all religion subject to the guidelines and health protocols embodied in an order to be issued separately.

SECTION 7. SPORTS ACTIVITIES. Indoor and outdoor non-contact sports limited to walking, jogging, running, biking, golf, tennis and badminton are allowed. Provided, that the minimum public health standards such as the wearing of masks and maintenance of social distancing protocols and no sharing of equipment where applicable, are observed. Provided further, that in case of tennis and badminton, no spectators and congregation of other players shall be allowed at the venue.

SECTION 8. CURFEW. Curfew hours shall be uniformed to all the municipalities of the Province of Lanao del Norte which is from 8:00 p.m. to 5:00 a.m.

SECTION 9. PROHIBITION ON PUBLIC CONSUMPTION OF ALCOHOLIC BEVERAGES. Public consumption of alcoholic beverages is strictly prohibited. The municipalities and barangays are mandated to ensure compliance of all establishments within their jurisdiction. Non-compliance of any establishment shall warrant the cancellation or non-renewal of its Business Permit by the municipality concerned.

SECTION 10. APPLICABILITY OF HOME QUARANTINE. The entire province being on a Modified General Community Quarantine shall still implement home quarantine, and thus, no leisure activities and travels shall be allowed especially those that belong to the following categories:

- a. Pregnant Women.
- b. People with immunodeficiency, or immune-compromised or with other health risks.
- c. Persons who are 20 years old and below, and those who are aged 60 and above except when indispensable under the circumstances for obtaining essential goods and services or for work in industries and offices which still employs aged 60 years old and above.
- d. Non-workers who are aged 21 to 59 years old except for the purpose of buying food, basic necessities, medicine and accessing medical services.

SECTION 11. BORDER QUARANTINE CHECK POINTS. The Border Quarantine Checkpoints established in the flowing areas are to be retained and shall strictly implement its border control policies:

- a. Poblacion, Linamon, Lanao del Norte
- b. Mukas, Kolambugan, Lanao del Norte
- c. Campong, Pantar, Lanao del Norte
- d. Maria Cristina, Balo-i, Lanao del Norte
- e. Inagongan Tagoloan, Lanao del Norte
- f. Caniogan, Tubod, Lanao del Norte
- g. Piraka, Sultan Naga Dimaporo, LND
- h. Tagolo, Sultan Naga Dimaporo, LND
- i. Taguitic, Kapataga, Lanao del Norte

The Border Quarantine Checkpoints shall be composed of the following:

- a. Members of the Armed Force of the Philippines;
- b. Members of the Philippine National Police;
- c. BFP
- d. Barangay Officials and Tanod;
- e. Members of the BHERT;
- f. Personnel from the Rural Health Unit (RHU); and
- g. Coast Guard.

SECTION 12. GUIDELINES IN MANNING THE BORDER QUARANTINE CHECKPOINTS ALONG NATIONAL HIGHWAYS. The following guidelines shall be implemented in every Border Quarantine Checkpoint:

- a. All checkpoint personnel must observe the universal precaution of hand washing/sanitizing, proper cough etiquette, social distancing and should wear and be equipped with Mask, Gloves, Goggles or safety glasses, alcohol, 12-inch stick used for inspection and Thermal Guns and adequate replacement batteries.
- b. The movement of all types by land, air or sea within and across areas placed under any form of community quarantine shall be unhampered. Workers in the logistics sector, such as cargo, trucking, courier delivery and port operations shall likewise be allowed to transit across areas placed under any form of community quarantine. Provided, that only a maximum of five (5) personnel may operate cargo and delivery vehicles by land, with or without load.

- c. The movement of the following persons within and across areas placed under any form of community quarantine shall be permitted:
 - 1. Health and emergency frontline services personnel.
 - Government officials and government frontline personnel.
 - 3. Duly-authorized humanitarian assistance actors (HAAs).
 - Persons traveling for medical for medical or humanitarian reasons.
 - Persons going to the airport for travel abroad.
 - Anyone crossing zones for work permitted in the zone destination, and going back home.
- d. Land, air or sea travel by uniformed personnel, government officials and employees for official business with the corresponding travel authority, and authorized HAAs, especially those transporting medical supplies and laboratory specimens related to COVID-19 and other relief and humanitarian assistance, shall be allowed.
- e. All existing Municipal and Barangay checkpoints shall remain to serve second line of defense, provided that no barangay checkpoint is allowed on national highways.

SECTION 13. GUIDELINES FOR OVERSEAS FILIPINO WORKERS (OFW), LOCALLY STRANDED INDIVIDUALS (LSI), AUTHORIZED PERSONS OUTSIDE RESIDENCE (APOR), RESIDENTS TRAVELLING TO OTHER PROVINCES AND VISITING NON-RESIDENTS OF THE PROVINCE. To facilitate the movement of people within, into and from the province, the following guidelines shall be observed:

a. FOR OVERSEAS FILIPINO WORKERS (OFW).

- Before their transport, the official list with their names and addresses shall be provided to the Incident Management Team of the Province of Lanao del Norte by the government agency that facilitated their transport.
- Their transport back to the province shall be in accordance with the established guidelines and protocols of the "Balik Lanorte Program" of the Incident Management Team.
- Upon entry, the Border Quarantine Checkpoints shall require the OFWs to present their Travel Authority, Medical Clearance Certificate and valid Identification Card. The Border Quarantine Checkpoints shall inform the IMT of the entry of the OFWs in order to subject them to the Mandatory Health Protocols established by the Provincial Government of Lanao del Norte.
- They shall at all times follow the minimum health protocols including wearing of mask and the observance of physical or social distancing.
- They shall be bound by the rules on public and private transportation provided under Section 5 hereof.

b. FOR VISITING NON-RESIDENTS OF THE PROVINCE

- Entry in the Province of Lanao del Norte for leisure, non-medical, non-work related and non-religious related travels is strictly prohibited.
- Upon entry, the Border Quarantine Checkpoints shall require them to present medical clearance certificate issued by the Municipal Health Office of their places of origin and a Travel Pass.
- They shall at all times follow the minimum health protocols including

wearing of mask and the observance of physical or social distancing.

• They shall be bound by the rules on public and private transportation provided under Section 5 hereof, non-compliance will result to refusal of their entry into the province or they shall be directed to disembark other passengers in excess of what is required under this executive order before they are allowed entry.

c. FOR AUTHORIZED PERSONS OUTSIDE RESIDENCE (APOR).

- Upon entry, the Border Quarantine Checkpoint shall require them to show their valid identification card.
- They shall at all times follow the minimum health protocols including wearing of mask and the observance of physical or social distancing.
- They shall be bound by the rules on public and private transportation provided under Section 5 hereof, non-compliance will result to refusal of their entry into the province or they shall be directed to disembark other passengers in excess of what is required under this executive order before they are allowed entry.

d. RESIDENTS (WHO ARE NOT APOR) TRAVELLING TO OTHER PROVINCES.

- The travel outside the Province of Lanao del Norte shall be allowed only for non-leisure travels which may include but not limited to medical related, work related and religious related travels.
- They are required to secure a TRAVEL CLEARANCE from the Incident Management Team (IMT) of the Province of Lanao del Norte.
- Before being issued a Travel Clearance, the traveling resident shall secure first a medical clearance certificate from the Municipal Health Office of their place of residence. It shall be presented to the Border Quarantine Checkpoints upon their return along with their valid Identification Cards.
- When returning from a travel outside the province, the traveling resident shall surrender the Travel Clearance to the assigned personnel at the Border Quarantine Checkpoints.
- They shall at all times follow the minimum health protocols including wearing of mask and the observance of physical or social distancing.
- They shall be bound by the rules on public and private transportation provided under Section 5 hereof, non-compliance will result to refusal of their entry into the province or they shall be directed to disembark other passengers in excess of what is required under this executive order before they are allowed entry.

e. FOR LOCALLY STRANDED INDIVIDUALS (LSI).

Locally Stranded Individuals (LSI) is defined under Department of the Interior and Local Government (DILG) *Memorandum Circular No. 2020-087* as Filipino Citizens or foreign nationals (e.g. Construction and domestic workers, tourists, students among others) in a specific locality within the Philippines who have expressed intention to return to their place of residence or home origin. LSIs can be further classified to Workers, Students, Tourists and other individuals stranded in various localities while in transit.

For proper guidance, per Department of the Interior and Local Government (DILG) *Memorandum Circular No. 2020-087* the authority to issue Travel Authority is given to the following:

- From one region to another region- The Regional Director of the Philippine National Police (PNP).
- From one province to another province within one region- The Provincial Director of the Philippine National Police (PNP).
- From one municipality to another municipality within the province-The Chief of Police.
- 4. From one municipality to another municipality which are adjacent to each other regardless of being in a different province or region, the Chief of Police of the concerned municipalities.

i. INCOMING LOCALLY STRANDED INDIVIDUALS (LSI)

- LSIs shall secure first before their travel, a Travel Authority from their places of origin by informing their respective barangays that they are LSIs.
- The Punong Barangay conducts inventory of LSIs in the barangays and submits the consolidated list to Municipal Local Government Unit through the LSI Focal Person.
- In processing the Travel Authority, the LSI should fill out first Form A (Registration Form) and Form B (Availability of Travel) at LSI Focal Person Office.
- The LSI shall secure a Medical Clearance Certificate from the Municipal Health Office.
- The LSI then secures a Travel Authority from the PNP-Municipal Police Station.
- The PNP-MPS processes the Travel Authority with attached Medical Clearance Certificate and Form B (Availability of Travel). The PNP-MPS shall provide a list of all approved Travel Authority to the LSI Focal Person, the DILG and the Incident Management Team of the Province of Lanao del Norte.
- Upon entry, the Border Quarantine Checkpoints shall require the LSIs to present their Travel Authority, Medical Clearance Certificate and valid Identification Cards. The Border Quarantine Checkpoints shall inform the IMT of the entry of the LSIs in order to subject them to the Mandatory Health Protocols established by the Provincial Government of Lanao del Norte.
- The LSIs shall at all times follow the minimum health protocols including wearing of mask and the observance of physical or social distancing.
- The LSIs shall be bound by the rules on public and private transportation provided under Section 5 hereof, non-compliance will result to refusal of their entry into the province or they shall be directed to disembark other passengers in excess of what is required under this executive order before they are allowed entry.

ii. OUTGOING LOCALLY STRANDED INDIVIDUALS (LSI)

- LSIs shall secure first before their travel, a Travel Authority from their places of origin by informing first their respective barangays that they are LSIs.
- The Punong Barangay conducts inventory of LSIs in the barangays and submits the consolidated list to Municipal Local Government Unit through the LSI Focal Person.
- In processing the Travel Authority, the LSI should fill out first Form A (Registration Form) and Form B (Availability of Travel) at LSI Focal Person Office.

- The LSI shall secure a Medical Clearance Certificate from the Municipal Health Office.
- The LSI then secures a Travel Authority from the PNP-Municipal Police Station.
- The PNP-MPS processes the Travel Authority with attached Medical Clearance Certificate and Form B (Availability of Travel). The PNP-MPS shall provide a list of all approved Travel Authority to the LSI Focal Person, the DILG and the Incident Management Team of the Province of Lanao del Norte.
- The LSIs shall at all times follow the minimum health protocols including wearing of mask and physical or social distancing.
- They shall be bound by the rules on public and private transportation provided under Section 5 hereof.

SECTION 14. MINIMUM HEALTH PROTOCOL IN ESTABLISHMENTS AND PUBLIC PLACES. The following health protocol shall be observed in establishments allowed to operate and in public places:

- a. Taking of body temperature;
- b. Strict social and physical distancing.
- c. Wearing of face masks, ear loop masks, reusable, do-it-yourself masks, face shields, handkerchiefs or such other protective equipment or a combination thereof, which can effectively lessen the transmission of COVID-19.
 - d. Use of alcohol or alcohol based sanitizers;
 - e. Regular disinfection of the work areas; and
 - f. Presence of sanitation stations.

SECTION 15. SEPARABILITY CLAUSE. If any provision of this Order is declared unconstitutional or invalid by appropriate courts, the other provisions unaffected thereby shall remain in full force and effect.

SECTION 16. REPEALING CLAUSE. All executive orders and issuance or parts thereof which are inconsistent with the provisions of this Order are hereby repealed or modified accordingly.

SECTION 17. EFFECTIVITY. This Order shall take effect at 12:01 am of June 1, 2020 and shall have force and effect until and unless lifted.

"AN EXECUTIVE ORDER PROVIDING FOR AMENDMENTS TO EXECUTIVE ORDER NO. 14 SERIES OF 2020"

WHEREAS, on 8 March 2020, the President Rodrigo Roa Duterte issued Proclamation No. 22 "DECLARING A STATE OF PUBLIC HEALTH EMERGENCY THROUGHOUT THE PHILLIPPINES" and mandated that "All government agencies and LGUs are hereby enjoined to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner to curtail and eliminate Covid-19 threat"

WHEREAS, on 27 May 2020, the Province of Lanao del Norte has maintained its status of being a Low Risk under Resolution No. 40 issued by the National Inter-Agency Taskforce for the Management of Emerging Infectious Diseases and was directed to transition from GENERAL COMMUNITY QUARANTINE (GCQ) to MODIFIED GENERAL COMMUNITY QUARANTINE (MGCQ);

WHEREAS, on 1 June 2020, Executive Order No. 14 was issued providing for the guidelines for MODIFIED GENERAL COMMUNITY QUARANTINE (MGCQ) in the entire Province of Lanao del Norte;

WHEREAS. there is a need to amend certain provisions of Executive Order No. 14. Series of 2020 in order to clarify the provisions and improve the implementation of the executive order;

WHEREAS, Section 465 (b) vii of Republic Act 7160 otherwise known as The Local Government Code of 1991 authorizes the Provincial Governor to carry out emergency measures as may be necessary during and in the aftermath of man-made and natural disasters;

NOW THEREFORE, I, IMELDA QUIBRANZA DIMAPORO, Provincial Governor of the Province of Lanao del Norte, by virtue of the power vested in me by the Local Government Code of 1991 and other pertinent laws of the Republic of the Philippines, do hereby direct and Order:

SECTION 1. The provision of paragraph 1 Section 1 of Executive Order No. 14 Series of 2020 is hereby amended to state that:

"WORK ARRANGEMENT. Work in government offices maybe at full operational capacity or under such alternative work arrangements as agencies may deem appropriate in accordance with the relevant rules and regulations issued by the CSC."

SECTION 2. The provision of Section 5 II (C) of Executive Order No. 14 Series of 2020 is hereby amended to state that:

"C. Motorcycles

Only one (1) back ride is allowed, provided that both the driver

and the passenger shall wear helmet, mask, gloves and jacket or long sleeves. Provided further, that motorcycles whose passenger is not an immediate family member are prohibited from operating in national highways. Provided finally, that motorcycles whose passenger is an immediate family member are allowed to traverse the national highway but they are required to get a certification from their respective barangays that the passenger is an immediate family member of the driver."

SECTION 3. The provisions of Paragraph 2, Section 11 of Executive Order No. 14 Series of 2020 are hereby amended to state that:

"The Border Quarantine Checkpoints shall be composed of the following:

- a. Members of the Armed Force of the Philippines;
- b Members of the Philippine National Police;
- c REP
- d. Barangay Officials and Tanod;
- e. Members of the BHERT;
- f. Personnel from the Rural Health Unit (RHU); and
- a. Coast Guard.
- h. <u>PERSONNEL FROM THE INCIDENT MANAGEMENT TEAM OF</u> THE PROVINCE OF LANAO DEL NORTE.

SEPARABILITY CLAUSE. If any provision of this Order is declared unconstitutional or invalid by appropriate courts, the other provisions unaffected thereby shall remain in full force and effect.

SECTION 7. REPEALING CLAUSE. All executive orders and issuance or parts thereof which are inconsistent with the provisions of this Order are hereby repealed or modified accordingly.

SECTION 8. EFFECTIVITY. This Order shall take effect immediately upon the signing hereof and shall have force and effect until lifted.
