# ADMINISTRATION OF THE 2024 SPECIAL PHILIPPINE EDUCATIONAL PLACEMENT TEST (PEPT)

To: Assistant Schools Division Superintendent Chief ES- Curriculum Implementation Division Chief ES- Schools Governance and Operations Division Public Elementary and Secondary School Heads Private Elementary and Secondary School Heads All Others Concerned

- 1. This has reference to DepEd Order No. 55, s. 2016 and DepEd Memorandum No. 034, s. 2024 titled Administration of the 2024 Special Philippine Educational Placement Test (PEPT). The Division Office, through the SGOD- School Management Monitoring and Evaluation Section, shall administer the Special Philippine Educational Placement Test (PEPT). The schedule will be on August 11, 2024 at Lanao del Norte National Comprehensive High School.
- 2. The following are learner's category who are eligible to take PEPT:
  - a. Learners from schools without government permit.
  - b. Learners from nonformal and informal education programs
  - c. Learners who have incomplete or no record of formal schooling
  - d. Learners with back subjects
  - e. Learners who need grade-level standards assessment, and
  - f. Learners who are overage for their grade levels.
- 3. To register, learners should submit the following documentary requirements:

### For new registrants/test-takers:

- a) Completed PEPT Registration Form
  \*Accomplished PEPT Registration Form (download the PEPT Registration Form from <a href="https://bit.ly/SpecialPEPT2024">https://bit.ly/SpecialPEPT2024</a>). No registration fee is required.
- b) Birth Certificate \*Original and one (1) photocopy of Birth Certificate duly authenticated issued by the Philippine Statistics Office Authority (PSA) or Local Civil Registrar.

  - \*Original and one (1) photocopy of the permanent school record,
  - Form 137 (Transcript of Records with school seal and signature of principal/administrator/registrar)
  - Form 138 (Report Card with school seal and signature of principal/administrator/registrar)
- d) ID Pictures
  - \*Two (2) pieces identical and recently taken 1x1 colored ID pictures with name tag.
  - Form 138 (Report Card with school seal and signature of principal/registrar)
- e) School Permit: Photocopy of School Permit to Operate/Government Recognition (for applicants from private schools)
- f) Endorsement letters from the SDO (if learners from school without government permit)

### For retakers & PEPT passers only:

- a) Completed Registration Form
- b) Original and one photocopy of the PEPT Certificate of Result (COR); and
- c) Identical and recently taken 1x1 colored ID pictures with name tag (2 pcs).
- 4. Screening and submission of the requirements shall be on or before **August 6, 2024 (Friday)** at SGOD- M&E Section, DepEd Division Office, Pigcarangan, Tubod, Lanao del Norte.
- 5. The guidelines on test administration, evaluation of PEPT documentary requirements, test administration, including roles and responsibilities of the testing personnel will be discussed during the virtual orientation on **Aug. 2, 2024** (Friday) @ 9:00 o'clock in the morning using the links https://bit.ly/virtual2024specialpept.

# ADMINISTRATION OF THE 2024 SPECIAL PHILIPPINE EDUCATIONAL PLACEMENT TEST

To: Undersecretaries

- 1. The Department of Education (DepEd), through the Bureau of Education Assessment (BEA), announces the **Administration of the 2024 Special Philippine Educational Placement Test (PEPT)** on **August 4, 2024**, for Luzon testing centers, and on **August 11, 2024**, for Visayas and Mindanao testing centers.
- 2. The PEPT is a nationally administered assessment for learners in special circumstances. The result of this assessment will allow these learners to access or resume schooling and/or obtain certification of completion by grade level in the DepEd formal system.
- The target registrants for PEPT are the following:
  - a. Learners from schools without government permit,
  - b. Learners from nonformal and informal education programs,
  - c. Learners who have incomplete or no record of formal schooling,
  - d. Learners with back subjects,
  - e. Learners who need grade-level standards assessment, and
  - f. Learners who are overage for their grade levels.
- No test registration fees shall be collected from the test registrants.
- 5. The placement of the PEPT qualifiers for this special test administration shall take effect in the current school year when the test is administered pursuant to Section 6 (Grade Level Placement Assessment) 2.b. of DepEd Order No. 55, s. 2016 titled Policy Guidelines on the National Assessment of Student Learning for the K to 12 Basic Education Program.

### **Test Registration**

6. The test registration shall be done in select schools division offices (SDOs) starting from the date this Memorandum is published until **July 24, 2024**.

7. The Special PEPT Registration Form can be downloaded from https://bit.ly/SpecialPEPTREg. Registrants shall submit the documentary requirements to the Division Testing Coordinator (DTC) at the nearest SDO. Below are the requirements for specific types of test registrants.

### a. For new test-takers

- Original and one photocopy of the birth certificate duly authenticated and issued by the Philippine Statistics Authority (formerly National Statistics Office) or by the Local Civil Registrar
- ii. Certified True Copy and one photocopy of the **permanent school record** (e.g., SF10/Form 137) signed by the school principal/registrar/school administrator)
- iii. Certificate of attendance in intervention programs or any proof of schooling (if applicable)
- iv. Two identical and recently taken 1x1 color ID pictures with name tags
- v. One copy of the accomplished PEPT Registration Form

### b. For test retakers

- i. Original and one photocopy of the **PEPT Certificate of Rating** (for applicants who need to retake a PEPT subtest)
- Two identical and recently taken 1x1 color ID pictures with name tags
- iii. One copy of the accomplished PEPT Registration Form
- 8. The DTCs shall be in charge of the evaluation of the documentary requirements. He/She must ensure the completeness of the requirements and the accuracy of the evaluation for each registrant.
- 9. Examinees whose test score in one subject is lower than 75% may be allowed to retake the failed subtest within six months from the date of the examination.
- 10. A Certificate of Rating (COR) shall be issued to each test-taker.

### Testing Centers, Test Materials, and Number of Registrants

- 11. The testing centers shall be located in select SDOs.
- 12. Some SDOs shall have more than one testing center.
- 13. BEA shall allocate the number of test materials per SDO and testing center based on the actual number of test registrants.
- 14. The DTCs are required to submit to BEA the actual number of Special PEPT registrants for the allocation and packing of test materials in the warehouse.
- 15. The Excel template to be used in the submission of the **actual number of test registrants** per testing center and updated names of testing centers (if applicable) can be downloaded from **https://bit.ly/TestingCenterAndRegistrants**.
