**ADOPTION OF THE GUIDELINES ON ENSURING A SAFE AND
MOTIVATING LEARNING ENVIRONMENT**

1. In line with **DepEd Order No. 006 (s. 2026)**, this Office directs all DepEd-Lanao del Norte personnel to adhere the **Guidelines on Ensuring a Safe and Motivating Learning Environment**. This policy harmonizes all DepEd issuances to guarantee a secure space for students.
2. This Order establishes **prevention and response** strategies to address incidents related to **Learner Rights and Protection (LRP)** concerns. It applies to both physical and virtual settings, including school grounds, activities, and off-campus environments.
3. As the primary government agency mandated to protect and promote the right of every Filipino to quality, equitable, culture-based, and complete basic education, **this Office advises the field** to strictly and diligently adopt these guidelines. This ensures an enabling environment where learners are motivated to learn and protected from abuse, violence, and harm.
