
GUIDELINES

- **A. Content.** The BigaTEN DepEd X Season 6, s. 2025 shall feature the 14 Schools Division Offices' (SDOs) various programs, initiatives, innovations, and best practices, among others, through the following:
 - 1. One Full and Continuous Original Documentary Video of not less than 45 minutes but not more than 120 minutes with English subtitles.
 - Note: In this Season, the divisions' documentary videos will be played continuously as one video material, that is, without the participation of Ka-DepEd PAULO and Ka-DepEd RADA as live regional hosts. The Regional Office's (RO) role, through the BigaTeam, will be limited to playing the divisions' complete documentary video as scheduled via the Facebook Platform.
 - 2. One Teaser Video (maximum of two minutes) that will include the Region's seai, Division's seai, BigaTEN logo, storyline, segment photos/video excerpts, livestreaming schedule, livestreaming platforms (Facebook and Youtube), and other relevant details.
 - 3. One 30-40-second infomercial based on the theme to be played in the middle of the documentary video (submit a separate video file for judging).
 - 4. One Promotional Poster. The SDOs are given the freedom to design their promotional poster using all the prescribed elements, including the theme, which are accessible via this link http://bit.ly/3IhrYGs.

Anchoring on the theme "In DepEd NorMin, we Learn and Win as One!" the SDOs may highlight success and inspiring stories from the field featuring the Alternative Learning System (ALS), Indigenous Peoples Education (IPEd), Special Education (SpEd), Basic Education Madrasah Program, and Last Mile Schools, among others.



The documentary videos must include the following default lines in both video intro and video outro, aside from the divisions' own taglines, among others:


- 1. RO Tagline: BigaTEN DepEd X: "We Learn and Win as One!"
- E. Materials Production and Certification. Engaging a third-party (non-DepEd) expert/professional (e.g., multimedia creator/editor/director, video maker/editor, graphic artist/content creator/media specialist, and the like), in producing all the materials enumerated in Letter B of the guidelines is NOT allowed. Preparation and production of these materials shall be subject to the no-disruption-of-classes policy stipulated in DepEd Order No. 9, s. 2005 titled Instituting Measures to Increase Engaged Time-on-Task; DepEd Order No. 66, s. 2017 (Policy on Off-Campus Activities), and the DOH/IATF-prescribed health and safety standards. Violation of any of these requirements will disqualify the concerned division from participating in the Pasidungog sa Amihanang Mindanao (PAM) Awards in December 2025. Hence, each division shall submit a certificate of non-engagement to third party (signed by the Schools Division Superintendent (SDS)) of its full compliance with these requirements.
- **r. Submission**. Please email all production materials, including the complete names of the production staff with their specific roles/functions and the materials production certification, at **pau.region10@deped.gov.ph**, not later than August 29, 2025.
- **G. Ranking System.** The winners will be determined through a standardized ranking system based on the judges' individual scores. Each judge will evaluate all entries and assign scores accordingly. The entries will then be ranked per judge, with the entry receiving the highest score assigned Rank 1, the next highest as Rank 2, and so forth. The final ranking for each entry will be calculated by summing the individual ranks assigned by all judges. The entry with the lowest cumulative rank total will be declared the winner. In the event of a tie, the entry with the highest rank placement across all judges wins.
- **H. Rewards and Recognition**. At the end of this Season, the Regional Office (RO) will give rewards and recognition to acknowledge the excellence of the participating divisions, schools, or individuals in the upcoming 2025 Pasidungog sa Amihanang Mindanao (2025 PAM) in December:

1. Best Broadcasters




