- d) Attestation that the applicant partner is within the eight-kilometer (8km) radius from the listed qualified DepEd public SHS.
  - e) For the applicant partner situated beyond the eight-kilometer (8 km) radius, an attestation of their exact location.
  - f) Certificate of Recognition from TESDA that it has the capacity to deliver the registered program with the preferred flexible learning mode, as indicated in the updated curriculum and Training Plan (TESDA Circular No. 62, s. 2020); and
  - g) The Training Plan shall include the in-person training and education of the select learner-beneficiaries and full in-person training education through DepEd Order No 35, s. 2022 and the plan in conducting in-person education / assessment.
3. The TVI applicant shall comply with the following eligibility criteria:
- a) The program must be registered with and accredited or organized by TESDA.
  - b) The TVI must be compliant with the latest applicable audits, including compliance, internal, on-the-spot, and operational audits.
  - c) The TVI must have the absorptive capacity encoded in the Scholarship Information System (SIS).
  - d) The offered programs or qualifications must be aligned with the Regional and/or Provincial Skills Priorities.
  - e) The TVI must not have been found guilty of any adverse findings, after due process, by the Regional Director as the Disciplining Authority.
  - f) The TVI must not be the subject of any unsettled Notice of Disallowance (ND).
