
CHRISTMAS DANCE-OFF: TikTok EDITION 2025

1. CRITERIA AND MECHANICS

Christmas Dance Off Competition

Participants: Teaching & Non-Teaching Personnel, Division of Lanao del Norte

Theme: "Groove, Glow, and Give: A Merry TikTok Christmas!"

MECHANICS:

1. Participants

- Each participating team shall consist of **10 to 15 members**, all of whom must be **teaching or non-teaching personnel** within the **Division of Lanao del Norte**.
- Members may be of **any gender**.

2. Performance Duration

- Each performance shall have a duration of **3 to 5 minutes**. A 10-second grace period before and after the allotted time will be allowed for entrance and exit.
- **Performances exceeding or falling short of the prescribed time limit** may result in **point deductions**. One (1) point deduction from each judge's total score shall be deducted for every 30-second extension beyond allowable time.

3. Music Selection

- Music must be a **creative mix of TikTok viral songs and Christmas songs** (either modern or classic).
- The transition between songs should be **smooth and cohesive**.
- Explicit or inappropriate lyrics are **strictly prohibited**.

4. Dance Style

- Any dance style or combination of styles may be used (e.g., hip-hop, modern, jazz, or interpretative).
- Movements and attire must remain **decent and appropriate** for a professional and public setting.

5. Costume and Props

- Teams are encouraged to wear **Christmas-themed costumes** (e.g., Santa hats, red/green attire, Christmas accessories).
- Use of **props** is allowed but must be safe and non-damaging to the venue.

6. Judging and Criteria

- The competition will be judged by a **panel of selected adjudicators** based on the criteria below.
- The **decision of the judges is final and irrevocable**.

7. Technical Requirements

- Teams must submit their **music file (MP3 format)** to the organizers **at least one day before the competition**.
- A **1-minute stage preparation time** will be given before each performance.

8. Conduct and Sportsmanship

- Teams are expected to exhibit **camaraderie and professionalism** throughout the event.
- Any act of misconduct may lead to **disqualification**.

CRITERIA FOR JUDGING

Criteria	Description	Percentage
Choreography & Creativity	Originality, formation, use of space, and creative integration of TikTok and Christmas themes	30%
Performance & Execution	Energy, synchronization, precision, and stage presence	25%
Costume & Visual Impact	Creativity, color coordination, and alignment with the Christmas theme	15%
Musicality & Timing	Rhythm, transitions between songs, and overall flow	15%
Audience Impact & Entertainment Value	Engagement, excitement, and overall entertainment factor	15%
