CLARIFICATION ON WORK ARRANGEMENT AND RESPONSIBILITIES OF COS-BASED ALIVE TEACHERS

TO: Chief of the Curriculum Implementation Division
Division MEP Supervisors
Public School District Supervisors, District In-charge, Coordinating Principals
Division MEP Composite Team, School Heads and Asatidz
All Other Personnel Concerned

- 1. This Office reiterates that Contract of Service (COS)-based ALIVE teachers are not covered by the Department of Education's Vacation Service Credits (VSC) policy. This clarification is supported by DepEd Order No. 009, s. 2025, amending DepEd Order No. 009, s. 2024 (Implementing Guidelines on the Calendar of Activities for S.Y. 2024–2025), which explicitly states under Item No. 4, Letter (c) that the ALIVE teachers referred to are only those holding permanent items, and not those hired under a Contract of Service.
- 2. COS workers are classified as **non-regular employees** under civil service regulations, and as such, they do not enjoy the same entitlements, including VSCs, given to regular plantilla teachers as per Civil Service Commission (CSC)-Commission on Audit (COA)-DBM JC No. 1, S. 2017
- 3. However, per the terms of their COS, the "No Work, No Pay" policy applies. As such, COS-based ALIVE teachers are still expected to render services during the break period, which includes but not limited to the following:
 - Submission of Action Plans and Accomplishment of Instructional Materials to the school head
 - Participation in summer activities, such as Brigada Eskwela, remedial programs
 - Preparation and submission of Monthly Daily Time Records (DTRs) and accomplishment reports

- 4. In light of this, School Heads are advised to exercise discretion in arranging flexible work schedules arrangements which is appropriate and consistent with the assigned duties outlined in the COS. COS-based ALIVE teachers are expected to complete at least 20 hours per week or 80 working hours per month, and all rendered outputs must be properly documented.
- 5. Immediate dissemination and compliance with this Memorandum are requested.
