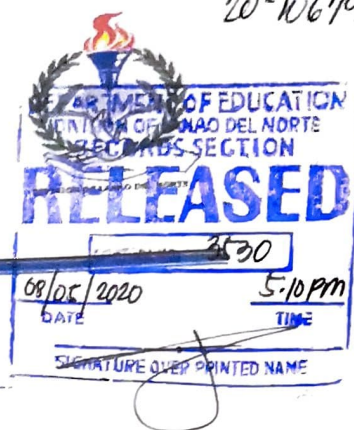

1.
