3. Participating schools are required to prepare designated testing area, ensure the availability of necessary equipment, and strictly follow the prescribed guidelines.

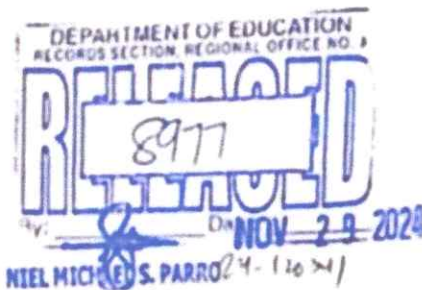

AND CONDUCT OF THE PISA MOCK POSTTEST

To: Schools Division Superintendents

1. Regarding RM No. 682, s. 2024 with the title Regional Unified Quarterly Assessment for SY 2024-2025, the Second Quarter Examination, originally scheduled for December 2-3, 2024, as per DepEd Order No. 9, s. 2024, is moved to December 3-4, 2024 to accommodate the 2024 Pasidungog sa Amihanang Mindanao (PAM) Activity.
