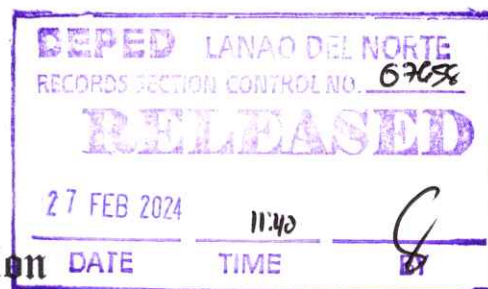

Teachers are also required to allow extension of submission deadlines on non-negotiable performance task requirements such as but not limited to research, portfolio, and the likes.
