**CORRIGENDUM AND ADDENDUM ON THE IMPLEMENTATION OF WORK
 FROM HOME ARRANGEMENT EVERY FRIDAY AS DISSEMINATED
 IN DIVISION MEMORANDUM NO. 160, S. 2026**

1. Based on the clarifications made by DepEd Central Office regarding the implementation of work-from-home (WFH) in unnumbered DepEd Memorandum dated March 11, 2026, the following corrections to Division Memorandum No. 160, s. 2026 are hereby issued:

1.1 The WFH arrangement applies only to non-teaching and related-teaching personnel in the Division Office.

1.2 Memorandum Circular No. 114, s. 2026 does not cover school-based personnel to ensure the orderly conduct of end-of-school-year (EOSY) activities.

2. All other provisions of Division Memorandum No. 160, s. 2026 shall remain in effect.

3. Additionally, officials and employees scheduled to be on WFH but have previously assigned activities outside the Division Office such as *Conduct of Comparative Assessment for Teacher I Applicants* and *SIP Presentations*, shall physically report to their respective assignments.
