

**8<sup>TH</sup> DIVISION ECHO-DANCE WORKSHOP ON PHILIPPINE FOLK DANCES 2025**


**To:** Public Schools District Supervisors/District In-Charge

1. In line with the continuing efforts to enhance the quality of instruction and school performance of MAPEH teachers in the delivery of Physical Education Curriculum, this Division through the Curriculum Implementation Division (CID) shall conduct a **Two - Day 8<sup>th</sup> Division Echo-Dance Workshop on Philippine Folk Dances** on October 3-4, 2025, 8:00 in the morning at Maigo Central ES, Maigo, Lanao del Norte.
2. The training aims to:
  - a. develop knowledge, skills, understanding and appreciation for folk and traditional dances as bridges of cultures and people of the Philippines;
  - b. upgrade competencies in teaching traditional Philippine dances among teachers, folk dance trainers, choreographers and students;
  - c. provide teachers with resource materials on dance such as hand-outs, music, and videos; and
  - d. provide a forum to discuss significant issues and concerns of MAPEH teachers.
3. Participants are select MAPEH elementary, secondary, senior high school teachers and facilitators handling Key Stage 1, 2, 3 & 4. They are likewise advised to wear comfortable dance attire during the workshop.
5. Teachers shall be given Service Credits as per DepEd Order No. 53, s. 2003 upon submission of the accomplished CSC Form 48.
6. Prior to the conduct of the activity, all dance speakers/teacher-models and facilitators are advised to report to **Pigcarangan Integrated School**, Tubod West District, Tubod, Lanao del Norte for the **pre-work activities** on September 12 & 19, 2025, 8:00 o'clock in the morning.
7. Enclosed are copies of the training matrix and list of resource speakers, facilitators, and participants (Enclosure No. 2)

8. Traveling expenses and other incidental expenses of the participants are chargeable against local funds/ school MOOE subject to usual auditing rules and regulations.
