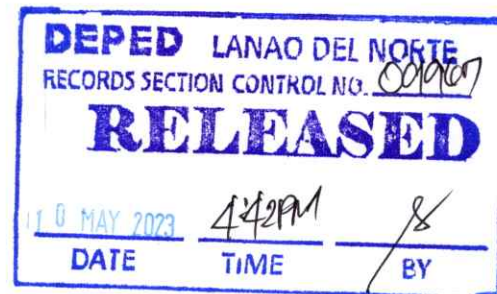


As a talented educator with a good track record in creating high-quality educational materials, we believe that his expertise and experience would be instrumental in highlighting the importance of inclusive education in our region.
