

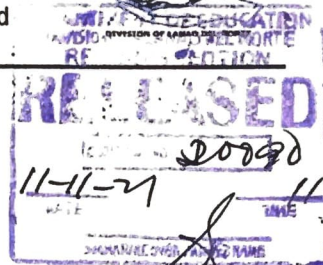

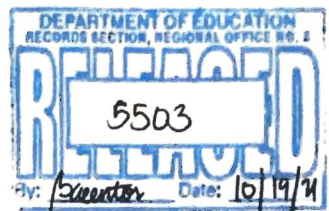

This refers to your query on whether winners of the DepEd TV Awards may be provided with incentives for purposes of promotion pursuant to our existing guidelines.

Upon perusal of the copy of the draft Aide Memoire on these awards, as furnished by your Office, we would like to respectfully inform you that the Outstanding Teacher-Broadcaster Awards may be considered as an outstanding accomplishment (Outstanding Employee Award) for purposes of appointment and promotion under DepEd Order No. 66, s. 2007 or the *Revised Guidelines on the Appointment and Promotion of Other Teaching, Related Teaching, and Non-Teaching Positions* for Teacher II and III positions, and MEC Order No. 10, s. 1979 or the *Implementing Rules and Regulations for the System of Career Progression for Public School teachers* for Master Teacher positions, which may be subject to issuance of further guidelines by the Personnel Selection Board (PSB) of the Regional and Schools Division Offices concerned.

As indicated in the aforesaid policies, below are the specific number of point/s assigned to Outstanding Accomplishments as a criterion in the evaluation of candidates for promotion:

Criterion For TI to TIII	Teaching and Teaching-Related	Non-Teaching Group	
		Level 1	Level 2
Outstanding Accomplishment			
a. Outstanding Employee Award	4 points	1 point	4 points



Criterion for Master Teacher	Points
1. Credited with Meritorious achievements such as: a. Trainor of or coach to contestants who received prizer, commendation or any form of recognition	National Winner- 10 pts. Regional Winner- 5pts. Division Winner - 3pts.

As requested, reference regarding the above criterion is included in the draft Aide Memoire on DepEd TV Awards, for your consideration.

Please be informed, however, that the foregoing consideration may only applicable under the Department's existing promotions policy. Once the Career Progression policy, a competency-based assessment based on the Philippine Professional Standards for Teachers (PPST), is adopted, awards such as these may only be used for rewards and recognition purposes only.
