DESIGNATION OF MUNICIPAL ALTERNATIVE LEARNING SYSTEM (ALS) FOCAL PERSONS TO STRENGTHEN PROGRAM IMPLEMENTATION

- 1. In line with the continuous improvement and efficient delivery of the Alternative Learning System (ALS) in the Division of Lanao del Norte, and in consideration of the need to strengthen ALS coordination and monitoring at the municipal level, this Office hereby designates an ALS Focal Person in each municipality within the Division.
- 2. Duties and Responsibilities of the ALS Focal Person:
 - a) Assist in the planning, implementation and monitoring of ALS programs in the municipality.
 - b) Serve as the point person for ALS-related matters and facilitate communication between the Schools Division Office and field implementers.
 - c) Consolidate and submit monthly reports on ALS learning sessions, learner progress, and challenges encountered.
 - d) Coordinate the conduct of community mapping and advocacy activities to increase ALS enrollment and community participation.
 - e) Facilitate the preparation and monitoring of ALS Action Plans aligned with the division's PPAs and the ALS K to 12 Basic Education Curriculum.
 - f) Serve as liaison in the coordination of ALS A&E registration, administration, and post-examination activities.
