2. The sub-committees are tasked to perform the following functions subject to the review and validation of the HRMPSTB:
 - a. Evaluate **Education, Training** (in hours), **Experience** (in years) and **Performance** of applicants using the appropriate rubrics.
 - b. Assess, deliberate, and rate applicants' competencies on a) **Classroom Observable Indicators** (COIs) through demonstration teaching; b) **Non-Classroom Observable Indicators** (NCOIs) based on teacher's demonstration and/or understanding of the indicators through portfolio annotations; and **Behavioral Events Interview** (BEI) following the rubrics and protocols provided in DO 24, s. 2025.
3. Since the deadline of PAL submission to the Regional Office is very close, the Sub-committees are **directed to consider their tasks as assessors a top priority** until the Comparative Assessment Result for Expanded Reclassification (CAREER) is submitted to the Division Office.
4. Sub-committees have the discretion to choose 3-5 Administrative Officers II in their district to work as members of the Secretariat.
5. Travelling expenses of Sub-committee members and Secretariat in the activity may be charged to local funds subject to the usual accounting and auditing rules and regulations.
6. This Memorandum shall serve as Authority to Travel of the Sub-committee members while the members of the Secretariat should secure travel authority/locator slip from their immediate head.
