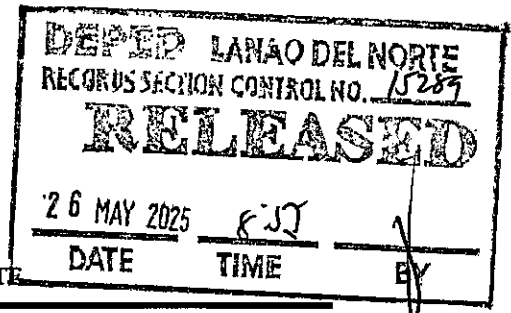

DISTRIBUTION OF TEXTBOOKS AND SELF-LEARNING MODULES (SLMs)

1. This memorandum outlines the schedule for the release and distribution of Self-Learning Modules (SLMs) and Textbooks for Elementary and Secondary learners. This schedule is critical to ensure timely access to learning materials for all students.
2. The distribution of textbooks and SLMs will be on May 28 - June 6, 2025 at the Division Office and Bagong Dawis Elementary School. Please adhere strictly to your designated date and time to ensure a smooth and orderly process.
3. The distribution list will contain only of quantity of the SLMs per district. Thus, this office instructs the Administrative Officers to be the one responsible in crafting the distribution list per school.
4. To streamline the process, the distribution of materials will be organized with a specific pick-up schedule for each district. Please visit the link < <https://bit.ly/distributionlist-and-schedule> > for the schedule and distribution list. Given the limited storage facility of the Division Office, school heads are requested to prioritize and ensure that the learning resources are picked up on schedule so as not to occupy the much-needed space for future supply deliveries.
5. School Heads of the same districts are advised to cooperate with each other when claiming, as releasing of the educational resources will be done by district.
6. Each district is further requested to assign at least two (2) representatives to pick up and check the quantity of the received learning modules.
