- 3. The District Focal Persons/In-Charge of the District Federation Election are required to submit the List of Officers (refer to Annex A) and Accomplishment Report (Narrative and photo documentation) on or before October 28, 2021 to Ms. Dimple G. Cabasis or Ms. Alva Joy N. Mugot.
- 4. The District and Division Federations shall elect the following positions:
 - a. President
 - b. Vice President
 - c. Secretary
 - d. Treasurer
 - e. Auditor
 - f. Public Information Officer (PIO)
 - g. Protocol Officer
- 5. Supreme Pupil/Student Government Teacher-Advisers are encouraged to attend the Division Federation Election as observer. Elected Presidents and Supreme Teacher-Advisers are required to accomplish the registration form:
