



1. Pursuant to RA 10533 otherwise known as the Enhanced Basic Education Act, the Department of Education- Division of Lanao del Norte, through the Curriculum Implementation Division, shall conduct Training of SPED and Receiving Teachers on Mainstreaming SPED Learners and Integrating Dance, Music and Arts in SPED Curriculum on August 29-31, 2017 at Mindanao Civic Center, Sagadan, Tubod, Lanao del Norte.

2. The workshop aims to:

- a. deliver the salient features of different special abilities
- b. understand inclusive education and appreciate mainstreaming
- c. integrate music, dance and arts as creative therapy in SPED Curriculum
- 3. Participants to this training are PSDSs and School Heads of the identified SPED and Receiving Teachers from SPED School Implementers in Lanao del Norte Division. Training matrix and facilitators/trainers and list of participants are attached accordingly.
- 4. Venue rental and meals and snacks shall be charged to Division INSET Funds (SPED Funds) while traveling and other incidental expenses of the participants and trainers/facilitators are chargeable against school MOOE/local funds subject to the usual accounting and auditing rules and regulations.
- 5. In order to effectively carryout the said training a meeting to all trainers / facilitators is set on August 4, 2017 at 8:30 in the morning at Maranding Central School.
- 6. Immediate dissemination of and strict compliance with this memorandum to all concerned is highly enjoined.
