1. In line with our commitment to strengthening early childhood education and ensuring aligned implementation of kindergarten programs across schools, a one-day **Consultative Meeting/Program Implementation Review (PIR)** for all Kindergarten District Lead Administrators will be conducted on **August 27, 2025** at **Guian's Function Hall**, Baroy, Lanao del Norte at 8:00 o'clock in the morning.
2. The specific objectives of this activity are:
