- Pursuant to Presidential Proclamation No. 279 dated October 7, 1994 which aims to mobilize all Filipinos for nation building through the practical exercise of human values in daily lives as citizens, the field is hereby informed of a Division Edukasyon sa Pagpapakatao (EsP) Festival of Talents on November 7, 2024 at Tubod Central Elementary School, Tubod, Lanao del Norte.
- The competition aims to:
 - provide better understanding on the importance of EsP in transforming the society;
 - demonstrate commitment to support the advocacy of EsP through healthy and friendly competition; and
 - enhance talents and skills of learner-participant and teacher-coach in the different events by promoting Filipino values.
- Please see enclosure No. 1 for the events to be contested and guidelines.
- A clustered district level elimination shall be held prior to the conduct of the division level competition. Only the cluster first place winner in every event shall compete in the division level. The Public Schools District Supervisors/ Coordinating School Principals and EsP District Principals are advised to facilitate the selection of the participants in every event to be contested.

**THEME, GUIDELINES AND CRITERIA FOR THE
2024 DIVISION EDUKASYON sa PAGPAPAKATAO COMPETITION**

A. General Theme:

**"Pananagutang pansarili, pamilya, kapwa, bansa, daigdig at
Diyos tungo sa kabutihang panlahat"**

B. Contest Events

b.1. LIKHA AWIT (OPM Songwriting Competition Elementary and Secondary)

1. The Cluster Winner for Best Composer/Composition shall be the official entry to the competition. One song is allowed per Cluster.
2. A learner- participant per cluster shall be accompanied by one coach.
3. The song must be written in Filipino.
4. The songwriter must write inspirational song using an adaptation of any popular music.
5. Song performance must not exceed three (3) minutes.
6. The performer may use guitar, minus-one or any form of keyboard.
7. Three (3) copies of the musical lyrics will be provided and must be encoded.
8. The contestant shall bring and wear their ID's for checking and verification.
9. The decision of the judges is final and irrevocable.
10. The following are the criteria for judging:

a. Content/Lyrics (relevance to the Theme)	30%
b. Voice Quality	30%
c. Interpretation/ Stage Presence	25%
d. Dynamics/ Tone / Rhythm	15%
Total	100%

b.2. ORATION (for Elementary Only- Grades 4-5)

1. There shall be one entry per cluster.
2. The substance should be relevant to the theme.
3. The delivery should not exceed to Three (3) minutes.
4. The following are the criteria:

a. Content Substance/Originality	50%
b. Delivery (3 minutes)	40%
c. Stage Presence/ Performance	10%
Total	100%
5. The decision of the judges is final and irrevocable.

b.3. EXTEMPORANEOUS SPEECH (for Secondary Level Only- Grades 7-10)

1. The delivery is within three (3) minutes.
2. The content message must be in Filipino.
3. There shall be one TOPIC which shall be given on the day of the competition.
4. The contestants must be placed in a secluded room closely guarded while waiting for their turn.
5. The coaches are not allowed to enter the room.
6. The following are the criteria:

a. Delivery (Diction/ Pronunciation/ Grammar/ Originality)-	40%
b. Stage Presence (Appropriate Gesture and Personal Appearance)	20%
c. Content Message/ Relevance to the Theme	40%
Total	100%
7. The decision of the judges is final and binding.

b.4 PICTURE STORY (Elementary and Secondary)

1. The Cluster first place winner shall be the official entry with one (1) coach.
2. Contestants should bring their own materials (1/2 illustration board and watercolor or pastel). They may use any color.
3. A picture story must be done in one (1) setting / scene.
4. The time limit is two hours.
5. The criteria of the contest are the following:

a. Content (Relevance to the Theme)	30%
b. Originality	40%
c. Design	30%
Total	100%
6. The decision of the judges is final and binding.

b.5 VIDEO PRODUCTION DEFECTING FILIPINO VALUES (Elementary and Secondary)

1. The top 2 winners from the Clustered EsP Festival of Talents are to be submitted in the division level competition.
2. The production of video should focus on the Most Essential Learning Competencies (MELC) showcasing the Filipino values. Some suggested contents are:
 - a. video that showcases a Filipino family tradition;
 - b. video that tells the story of a Filipino who has overcome challenges through hard work and resilience;
 - c. video that highlights the importance of Bayanihan in the Filipino community;
 - d. video that promotes Filipino culture and values; and
 - e. video that inspires Filipinos to be proud of their heritage.
3. Contestants shall be a team composed of Five (5) members either from Grades 4, 5 & 6 for the elementary and Grades 8, 9 & 10 for the secondary level.
4. The video must not exceed 3 minutes in length, must be in high definition (HD) resolution, original and must not be plagiarized, and in MP4 format.

5. Submission of entries shall be on or before November 6, 2024 through this email dennis.dozano001@deped.gov.ph.
6. By submitting an entry, participants agree to grant the Division Office the right to use their videos for teaching-learning purposes after it passed the Division Quality Assurance Team.
7. An entry that does not meet the submission requirements or that is deemed to be offensive or inappropriate is disqualified.
8. The decision of the judges is final and binding.
9. The criteria for judging are as follows:

a. Creativity and Originality	30%
b. Technical Execution	30%
c. Impact	40%
Total	100%
