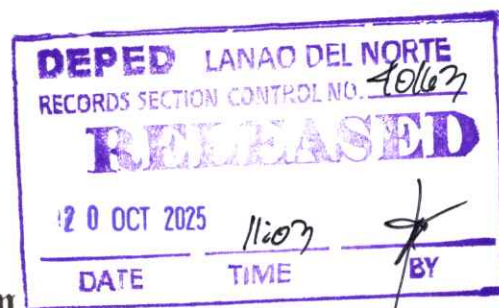

**DIVISION GOOD MANNERS AND RIGHT CONDUCT & VALUES
EDUCATION (GMRC-VE) FESTIVAL OF TALENTS 2025**

To: Public Schools District Supervisors/District in Charge

All Others Concerned

- Pursuant to Presidential Proclamation No. 279 dated October 7, 1994, which seeks to mobilize all Filipinos for nation-building through the practical exercise of human values in daily life as responsible citizens, this Office announces the conduct of the Division Good Manners and Right Conduct and Values Education (GMRC-VE) Festival of Talents on November 21, 2025, to be held at Tubod Central Elementary School, Tubod, Lanao del Norte.
- The competition aims to:
 - deepen understanding of the importance of GMRC-VE in transforming society;
 - demonstrate commitment to supporting GMRC-VE advocacies through healthy and friendly competition; and
 - develop and enhance the talents and skills of learner-participants and teacher-coaches in various events that promote core Filipino values.
- Please refer to Enclosure No. 1 for the list of events and detailed guidelines.
- A clustered district-level elimination shall be conducted prior to the division-level competition. Only the first-place winners in each event at the cluster level shall qualify for the division competition.
- The Public Schools District Supervisors (PSDSs), PSDICs, and GMRC-VE District Coordinators are enjoined to facilitate the conduct of the cluster-level eliminations and ensure the fair selection of participants for each event.

**THEME, GUIDELINES AND CRITERIA FOR THE 2025 DIVISION
GMRC-VE Festival of Talents**

A. Theme:

**"Matatag na Pagpapakatao, Matatag na Bansang Pilipino"
"(Strong Values, Strong Nation)"**

B. Contest Events

1. LIKHA AWIT (Elementary and Secondary)

- a. The Cluster Winner for Best Composer/Composition shall be the official entry to the competition. One song is allowed per Cluster.
- b. A learner- participant per cluster shall be accompanied by one coach.
- c. The song must be written in Filipino.
- d. The songwriter must write inspirational song using an adaptation of any popular music.
- e. Song performance must not exceed three (3) minutes.
- f. The performer may use guitar, minus-one or any form of keyboard.
- g. Three (3) copies of the musical lyrics will be provided and must be encoded.
- h. The decision of the judges is final and irrevocable.
- i. The following are the criteria for judging:

- Content/Lyrics (relevance to the Theme)	30%
- Voice Quality	30%
- Interpretation/ Stage Presence	25%
- Dynamics/ Tone / Rhythm	15%
- Total	100%

2. ORATION (Key Stage 2 only)

- a. There shall be one entry per cluster.
- b. The substance should be relevant to the theme.
- c. The delivery should not exceed to Three (3) minutes.
- d. The following are the criteria:

- Content Substance/Originality	50%
- Delivery (3 minutes)	40%
- Stage Presence/ Performance	10%
- Total	100%
- e. The decision of the judges is final and irrevocable.

3. EXTEMPORANEOUS SPEECH (Key Stage 4 only)

- a. The delivery is within three (3) minutes.
- b. The content message must be in Filipino.

- c. There shall be one TOPIC which shall be given on the day of the competition.
- d. The contestants must be placed in a secluded room closely guarded while waiting for their turn.
- e. The coaches are not allowed to enter the room.
- f. The following are the criteria:
 - 40% Delivery (Diction/Pronunciation/Grammar)
 - 20% Stage Presence (Appropriate Gesture and Personal Appearance)
 - 40% Content Message/ Relevance to the Theme
 - 100% Total
- g. The decision of the judges is final and binding.

4. Draw and Tell (Key Stage 1 and Key Stage 3)

- a. The Cluster first place winner shall be the official entry with one (1) coach.
- b. Contestants should bring their own materials (1/2 illustration board and any coloring materials). They may use any color.
- c. There shall be one theme which shall be given on the day of the competition.
- d. The time limit is two hours.
- e. The criteria of the contest are the following:

- Content (Relevance to the Theme)	30%
- Originality	40%
- Color and Design	30%
- Total	100%
- f. The decision of the judges is final and binding.

5. VIDEO PRODUCTION DEFECTING FILIPINO VALUES (Elementary and Secondary)

- a. The top 1 winner from the Clustered GMRC-VE Festival of Talents are the official entry in the division level.
- b. The content of the video production should focus on the Matatag Learning Competencies showcasing the Filipino values to be developed.
- c. The video must not exceed 3 minutes in length, must be in high definition (HD) resolution, original and must not be plagiarized, and in MP4 format.
- d. By submitting an entry, participants agree to grant the Division Office the right to use their videos for teaching-learning purposes after it passed the Division Quality Assurance Team.
- e. An entry that does not meet the submission requirements or that is deemed to be offensive or inappropriate is disqualified.

 - Technical Execution 30%
 - Impact 40%
 - Total 100%
