1. Pursuant to Presidential Proclamation No. 1906, s. 2009 declaring the Month of October of every year as National Indigenous Month, this Office, through the Curriculum Implementation Division (CID), will conduct a Division Indigenous Peoples (IP) Month Celebration and IPED Summit on November 29, 2023, at Dalama Integrated School, Dalama, Tubod, Lanao del Norte. For this year's celebration, DepEd shall be guided by the theme, "*Katutubong Karunungan Tungo sa Ingklusibong Kaunlaran.*"
2. This year's celebration will highlight activities and milestones dubbed as "Remembering the Journey of IPed" as we celebrate the 2<sup>nd</sup> Decade Years of the Indigenous Peoples Education (IPed) Program over the years through the following:
  - a. Ritual for thanksgiving, protection and healing;
  - b. Continuing dialogue and partnership with the Council of Elders;
  - c. Showcasing of cultural songs, dances, and games, and
  - d. Quiz Bee on Subanen Orthography.
3. Each school shall send delegates to the celebration composed of a school head, teachers, 15 learners and IP elders/ stakeholders. Every school shall render a cultural presentation by the learners, teachers or elders.

4. Dalama Integrated School is requested to prepare the preliminaries of the activities. Participating schools shall take charge of their respective provisions. This Memorandum serves as the Authority to Travel.
5. Travel and other incidental expenses of participants shall be charged to the school's MOOE/ local funds subject to the usual accounting and auditing rules and regulations.
