**CLARIFICATION ON THE VACCINATION SCHEDULING IMPLEMENTATION  
OF SCHOOL BASED-IMMUNIZATION PROGRAM 2025**

1. In pursuance to Regional Memorandum No. 728, s. 2025 titled "Clarification on the Implementation of School-Based Immunization 2025" vis-à-vis 2025 School-Based Immunization Program Implementation (Division Memorandum No. 468, s. 2025), this Office adheres to its clarified vaccination scheduling conditions:

- a. The designation of Fridays is primarily intended for regular catch-up immunization activities, especially in response to increased cases of vaccine-preventable diseases or outbreaks.
- b. Flexibility in scheduling school vaccination days will be allowed to effectively accommodate the target number of eligible learners, which may necessitate administering vaccines on days other than Friday, depending on the number of target learners, availability of learners, and logistical considerations.

2. To strengthen the vaccination activities so that 95 percent of the target learners are reached, all school heads and teachers are enjoined to fully support the School Health Section personnel in coordinating with their respective Rural Health Unit(s) for the School-Based Immunization Program acceptance campaign among parents and guardians of Grade 1 (males & females), Grade 4 (females), and Grade 7 (males and females) with emphasis on the safety and effectiveness of the vaccines to help secure parental consent prior to vaccination schedules in each school.

3. All school nurses are directed to provide active contact numbers of their respective Rural Health Unit (s) to all school heads of their assigned schools/district for proper correspondence purposes.

1. The Department of Health (DOH), in collaboration with the Department of Education (DepEd) Region X, will be implementing the School-Based Immunization 2025 vis-à-vis Regional Memorandum No. 634, s. 2025 issued on August 19, 2025.

2. As per attached letter of the DOH-CHD-NM, dated August 26, 2025, on school vaccination days for SBI Program, the following clarifications were made:

- a. The designation of Fridays is primarily intended for regular catch-up immunization activities, especially in response to increased cases of vaccine-preventable diseases or outbreaks.
- b. Flexibility in scheduling school vaccination days will be allowed to effectively accommodate the target number of eligible learners, which may necessitate administering vaccines on days other than Friday, depending on the number of target learners, availability of learners, and logistical considerations.

3. To strengthen the vaccination activities so that 95 percent of the target learners are reached, the principals/school heads and teachers shall fully support the school health personnel and coordinate closely with regional, provincial, and city health officers for the SBI acceptance campaign among parents and guardians of learners with emphasis on the safety and effectiveness of the vaccines to help secure parental consent prior to vaccination schedules in each school.
