

Election of Federated Parent-Teacher Associations (PTAs) SY 2021-2022

1. Pursuant to DepEd Order No. 13, s. 2022 titled Omnibus Guidelines on the Regulation of Operations of Parent-Teacher Associations (PTAs), this Office will conduct an Election of Federated Parent-Teacher Associations (PTAs) SY 2021-2022 on **April 19, 2022** at 8:00 AM in Lala National High School, Lala, Lanao del Norte.
2. Relative to this, all school heads are directed to hold simultaneous elections of PTAs by district until April 13, 2022 and submit their list of PTA Officers on **April 18, 2022** by filling in the google sheet through this link <https://tinyurl.com/SchoolPTAOfficers>. Likewise, PTA officers of all secondary schools are required to join their respective districts.
3. In case of schools where PTA officers are yet to be elected for SY 2021-2022, the election of their new set of SPTA/FPTA officers for SY 2021-2022 shall be governed by these guidelines. However, given the continuing challenges posed by COVID- 19 pandemic and the actual date of effectivity of these guidelines (which shall fall during the third quarter of SY 2021-2022), all schools are given until **April 18, 2022** to carry out such election and other SPTA and FPTA-mandated activities, including, but not limited to the following:

38.1 election of HPTA, GTPA, SPTA-BOD, and FPTA-BOD officers;
38.2 submission of accomplishment and financial reports;
38.3 turnover of all records and documents to the incoming SPIA/ FPTA officers; 38.4 conduct of school General Assembly (GA); and
38.5 all SPTA/ FPTA related activities required to be complied with under these guidelines but provide for an earlier deadline or period within which to satisfy such requirements.

4. Moreover, newly elected PTA Presidents per District are required to attend the Election of Federated Parent-Teachers Association SY 2021-2022.
5. In line with this, the Public Schools District Supervisors shall facilitate the said activity in their assigned districts.
