IMPLEMENTATION REVIEW ON OPEN HIGH SCHOOL PROGRAM (OHSP)

1. Open High School Program (OHSP) is an alternative mode of delivering secondary education both for public and private schools. It puts premium on independent ,self-pacing and flexible study to reach learners who are unable to start or complete secondary education due to problems of time,distance,physical impairment ,financial difficulties ,social or family problems. In order to identify the key performance indicators for evaluating the program's effectiveness, it is necessary to review existing policies on the implementation of OHSP in the hope of making them more responsive to the current learners` needs and context.

2. Relative to the implementation of Open High School Program via ADMs, this Office through the Curriculum Implementation Division (CID) will conduct an implementation review for Open High School Program (OHSP) at Guian's Function Hall , Baroy Lanao del Norte on November 21-22, 2025.

3. The activities aim to;

- a. Gain insights on how OHSP is implemented in the schools.
- b. Reflect on how OHSP contribute to quality, inclusive, relevant and liberating education for all types of learners who are in emergencies and other difficult circumstances.
- c. Elicit the initiatives, issues and concerns and challenges encountered by the schools in the implementation of OHSP.
- d. Provide technical assistance to the implementing schools to improve implementation of OHSP program.

4. The participants of this activity, who are OHSP coordinators of implementing secondary school heads, are expected to:

- Bring a laptop, extension cord and mode of verification (MOVs) related to the implementation of OHSP.
- To prepare a 3-8-minute presentation regarding the program implementation. Following the attached template.
- Provide relevant inputs and suggestions during the discussions; and
- Develop an action plan on the improvement of the implementation of the ADM in their respective schools.

5. The participants are entitled to *Vacation Service Credit (VSCs)* in accordance with Deped Order No.013 s. 2024*Revised Guidelines on the Grant of VSCs for Teachers or compensatory Time-Off pursuant to CSC-DBM joint Circular No.2 s. 2004" Non-Monetary Renumeration for Overtime Service Rendered, whichever is applicable.

6. Travel and other incidental expenses of the participants shall be charged to the school's MOOE and other funds subject to the usual government accounting policies and auditing rules and regulations.
