1. Pursuant to Regional Memorandum No. 0623, s. 2023 dated October 13, 2023, re: Involvement of School Division Offices, District Offices, and School Officials to City/Municipality/Barangay Anti-drug Abuse Council, this office directs all District Offices and School Officials to be actively involved in the Anti-Drug Abuse Council in their respective locality.
2. This directive aims to;
  - a. strengthen the implementation of the National Drug Education Program (NDEP).
  - b. motivate program implementers to manifest enthusiasm, leadership, and deeper commitments to the implementation of the program.
  - c. intensify school-local government unit (LGU) collaboration in maintaining an entirely drug-free environment in school, home, and community.
  - d. improve the sustainability of drug prevention advocacy.
3. All School Heads, PS District Supervisors/District in Charge are advised to attend or send a representative/alternate-NDEP Coordinator to a monthly and quarterly meeting of BADAC and MADAC in their locality.
4. A copy of the Certificate of Membership of BADAC and CADAC shall be submitted to the School Health Section in the Division Office on or before December 13, 2023, for consolidation and submission to the Regional Office.
