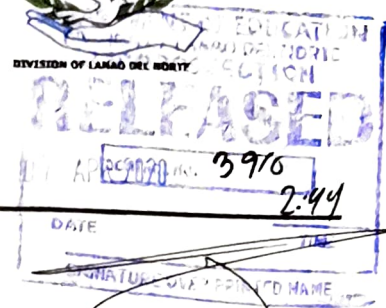

SUBJECT: LGU REQUESTS FOR THE USE OF THE FACILITIES OF THE DEPARTMENT OF  
EDUCATION AS ISOLATION OR QUARANTINE AREAS

1. Pursuant to DILG Memorandum Circular No. 2020 - 062 *re: LOCAL GOVERNMENT UNITS (LGUs) REQUESTING DEPED IN THE USE OF ITS FACILITIES AS ISOLATION OR QUARANTINE AREAS*, this office hereby informs the field that such requests are subject to the approval of the DepEd Regional Director, and to other guidelines and protocols that may be imposed, and to the DepEd Office Memorandum OM-OSEC-2020-002 relative to the use of DepEd schools as quarantine areas.
2. For requests to use DepEd facilities other than isolation or quarantine areas, the LGUs are also to directly submit their requests to the DepEd Regional Director and must comply with the necessary requirements it may impose.
3. All LGU related requests with recommendations from this office are forwarded to the DepEd Regional Director for proper assessment and consideration.

**SUBJECT :**            **LGU REQUESTS FOR THE USE OF THE FACILITIES OF THE  
DEPARTMENT OF EDUCATION AS ISOLATION OR  
QUARANTINE AREAS**

Pursuant to DILG Memorandum Circular No. 2020-062, local government units (LGUs) may request the Department of Education (DepEd) to use its facilities, including schools, as isolation or quarantine areas, subject to the approval of the DepEd, and to other guidelines and protocols that may be imposed, and to the DepEd Office Memorandum OM-OSEC-2020-002 relative to the use of DepEd schools as quarantine areas.

All DILG Regional Directors are directed to notify all LGUs within their areas of jurisdiction of the guidelines and protocols under the DepEd issuance, and subsequently direct LGU-related requests to the DepEd Regional Director for proper assessment and consideration.

DILG Regional Directors are also directed to assist LGUs in complying with the requirements of the DepEd for the approval of their requests, and ensure that all are acted upon, and complied with by the LGU efficiently, taking into consideration the urgency of the matter, and its probable impact to the efforts to fight the COVID-19 threat.

For requests to use the DepEd facilities other than as isolation or quarantine areas, the LGUs are also to directly submit their requests to the DepEd Regional Directors and must comply with the necessary requirements it may impose.
