**OBSERVANCE OF LEGAL MUSLIM HOLIDAY – AMUN JADID
(ISLAMIC NEW YEAR)**

1. This Memorandum is issued to disseminate the attached Regional Holiday Advisory from the National Commission on Muslim Filipinos (NCMF) Northern Mindanao, dated June 8, 2026. The advisory concerns the **OFFICIAL OBSERVANCE OF AMUN JADID (ISLAMIC NEW YEAR)**, a Muslim Holiday on 1 Muharram 1448H, which corresponds to **JUNE 16, 2026 (TUESDAY)**.
2. Pursuant to Presidential Decree No. 1083 (Code of Muslim Personal Laws of the Philippines), all government officials and employees working in areas which are officially enumerated in the said Memorandum shall be excused from reporting to office and all classes are hereby suspended to allow everyone to join the observance of the Islamic New Year.
3. All Division Office department heads and public schools district supervisors are directed to ensure that this information is properly communicated to all personnel within their respective units.

REGIONAL HOLIDAY ADVISORY

In accordance with Presidential Decree No. 1083, otherwise known as the *Code of Muslim Personal Laws of the Philippines*, and pursuant to the observance of **Amun Jadid (Islamic New Year)** on **1 Muharram 1448H**, corresponding to **16 June 2026 (Tuesday)**, all Muslim government officials and employees are hereby reminded of the provisions governing the observance of Muslim holidays.

Article 170. Provinces and cities where officially observed.

1. *Muslim holidays shall be officially observed in the Provinces of Basilan, Lanao del Norte, Lanao del Sur, Maguindanao, North Cotabato, Sultan Kudarat, Sulu, Tawi-Tawi, Zamboanga del Norte and Zamboanga del Sur, and in the Cities of Cotabato, Iligan, Marawi, Pagadian and Zamboanga and in such other Muslim provinces and cities as may hereafter be created.*
2. *Upon proclamation by the President of the Philippines, Muslim holidays may also be officially observed in other provinces and cities.*

Article 171. Dates of observance. The dates of Muslim holidays shall be determined by the office of the President of the Philippines in accordance with the Muslim Lunar Calendar (HLIRA).

Article 172. Observance of Muslim employees.

1. *All Muslim government officials and employees in places other than those enumerated under Article 170 shall also be excused from reporting to office in order that they may be able to observe Muslim holidays.*
2. *The President of the Philippines may, by proclamation, require private offices, agencies or establishments to excuse their Muslim employees from reporting for work during a Muslim holiday without reduction in their usual compensation.*
