1. This Memorandum is issued to disseminate the attached memorandum from the National Commission on Muslim Filipinos (NCMF) Northern Mindanao, dated August 17, 2026. The memorandum concerns the OFFICIAL OBSERVANCE OF HIJRAH (2026) MAULIDIN NABI OR BIRTHDAY OF PROPHET MUHAMMAD S.A.W., a Muslim Holiday on **AUGUST 26, 2026 (WEDNESDAY)**.

2. Pursuant to Presidential Decree No. 1083 (Code of Muslim Personal Laws of the Philippines), all government officials and employees working in areas which are officially enumerated in the said Memorandum shall be excused from reporting to office and all classes are hereby suspended to allow everyone to join the observance of the aforementioned Muslim Holiday.
