OBSERVANCE OF EID'L FITR 1443 HURAH OR CULMINATION OF THE HOLY MONTH OF RAMADHAN AND DECLARATION OF NATIONAL HOLIDAY

Date : April 18, 2022

All NCMF Officials and Employees are hereby informed that upon consultation with Darul-Ifta' of the Bangsamoro Autonomous Region in Muslim Mindanao and NCMF Ulama Interim Advisory Group, the 30° day of Ramadhan 1443H will be on May 2, 2022. Thereby, the first day of Shawwal 1443H will fall on May 3, 2022, a day in Observance of the EID'L FITR or culmination of the Fasting Month of Ramadhan 1443H throughout the country.

In this regard, with the provision of R.A. 9177 dated November 13, 2002, the NCMF has recommended to the Office of the President of the Republic of the Philippines to declare May 3, 2022, Tuesday, as National Holiday. Muslims all over the world observe the Eid'l Fitr Festival in three days to give ample time in celebrating the occasion together with their loved ones.

It is emphasized the observance of Eid'l Fitr as National Holiday is anchored on the presumption that everything will return to normal. Otherwise, we shall continue observing guidelines and those that may be issued by the Inter-Agency Task Force on COVID-19 pandemic.
