DepEd MEMORANDUM

No. **041**, s. 2024

REITERATION OF THE "NO COLLECTION POLICY" IN SCHOOLS

To: Undersecretaries
Assistant Secretaries
Bureau and Service Directors
Regional Directors
Schools Division Superintendents
Public Elementary and Secondary School Heads
All Others Concerned

1. Following Republic Act No. (RA) 4206, also known as "**An Act Prohibiting the Sale of Tickets and/or the Collection of Contributions for Whatever Project or Purpose from Students and Teachers of Public and Private Schools, Colleges and Universities,**" as amended by RA 5546, the Department of Education (DepEd) issued DepEd Order (DO) No. 19, s. 2008, titled "Implementation of No Collection Policy in All Public Elementary and Secondary Schools," prohibiting the collection of fees from learners during the enrolment period and at any time during the school year.
2. Pursuant to Section 1, RA 4206, as amended by RA 5546, it is hereby reiterated that "**the sale of tickets and/or the collection of contributions in any form whatsoever, by any person for any project or purpose, whether voluntary or otherwise, from school children, students and teachers of public and private schools, colleges and universities is hereby prohibited: Provided, however, that this prohibition shall not cover membership fees of school children and students the Red Cross, the Girl Scouts of the Philippines and the Boy Scouts of the Philippines: Provided, finally, that this Prohibition shall not cover the contributions of parents and other donors for the support of barrio high schools.**"
3. Section 2, RA 4206, as amended, provides that non-compliance with the aforementioned prohibition shall be penalized with a fine or imprisonment for not more than one month, or both, in the discretion of the court.
4. All DepEd personnel are advised of DO No. 49, s. 2022, titled *Amendments to DepEd Order No. 047, s. 2022 (Promotion of Professionalism in the Implementation and Delivery of Basic Education and Programs and Services)*. This directive serves as reminder to DepEd personnel to **refrain from unwarranted solicitations and collection of contributions.**
5. This Order hereby underscores the policy that sales of tickets and/or all forms of contributions, voluntary or otherwise, are prohibited except for the instances provided under RA 4206, as amended.



6. All previous issuances which are inconsistent with the provisions of this Order are hereby repealed or modified accordingly.
7. All Regional and Schools Division Offices are instructed to establish their respective monitoring mechanisms and ensure the continuing compliance of schools with aforementioned Department issuances.
8. Immediate dissemination of and strict compliance with this Memorandum is directed.

This plan shall NOT cover POLITICIANS for any losses resulting from Murder and/or Assault whether provoked or unprovoked

Exclusions; (Walay Labot)

PERSONAL ACCIDENT

This plan shall not cover any loss resulting from or related to:

- War or war-like operations
- Military or police service, except when off-duty
- Willful participation in any crime
- Self-inflicted injury or attempted suicide
- Osteoporosis
- Childbirth, miscarriage or any pregnancy-related complications
- Accident while under the influence of alcohol or unprescribed drugs
- Driving w/o license and LTO registration
- Hazardous sports
- Flying except as fare paying passenger in any licensed or private aircraft
- Racing
- Rape
- Pre-existing condition

HOSPITAL DAILY ALLOWANCE

This plan shall not cover any loss resulting from or related to:

- War or war-like operations
- Military or police service, except when off-duty
- Willful participation in any crime
- Self-inflicted injury or attempted suicide
- Childbirth, miscarriage or any pregnancy related complications
- Congenital anomalies and conditions arising there from
- Plastic surgery (except as a result or accident)
- Murder, frustrated murder of any attempt thereof
- Dental care of surgery (except as a result or accident)
- Routine health checks
- Alcoholism and drug addiction
- AIDS and other sexual transmitted diseases
- Hernia
- Mental or nervous disorders
- Racing in any form
- Dangerous or hazardous sports
- Pre-existing conditions will be waived after 6 months from the date of effectivity or coverage
