

**POOLING OF QUALIFIED APPLICANTS FOR THE 2025 NATIONAL ASSESSMENT FOR SCHOOL HEADS**

To: Assistant Schools Division Superintendent

1. In preparation for the upcoming **2025 National Assessment for School Heads**, this Office shall conduct a pooling of Qualified Applicants following the qualifications and the level of priority in the shortlisting of applicants.
2. Accordingly, DO 019, s. 2025, titled *Amended Qualification Standards for Teachers I-III, Master Teacher I-IV, and School Principal I-IV Positions, and the Qualification Standards for Newly Created Teacher IV-VII and Master Teacher V Positions*, which formally adopts Civil Service Commission (CSC) Resolution No. 2500471 dated May 28, 2025, provides the revised Qualification Standards (QS) for the School Principal I position, as detailed below:

- Head Teachers and Assistant School Principals (regardless of whether they meet the QS for School Principal I)
- Teachers-in-Charge
- FY 2021 NQESH Category C Takers
- FY 2023 NQESH Category B and C takers

4. For initial profiling of qualified applicants, ***approved performance rating, Service Record, Transcript of Records or Diploma*** certifying the attainment of relevant master's degree, ***Designation or Special Order as School Head or TIC/OIC of a public school duly signed by the Schools Division Superintendent***. Thus, interested applicants shall register and upload a ***certified true copy*** of the documents in ***PDF format*** at <https://tinyurl.com/2025nashapplicants>. Please log in your Office 365 account upon accessing the link.

5. The deadline for registration and submission of documents shall be on ***November 21, 2025***.
