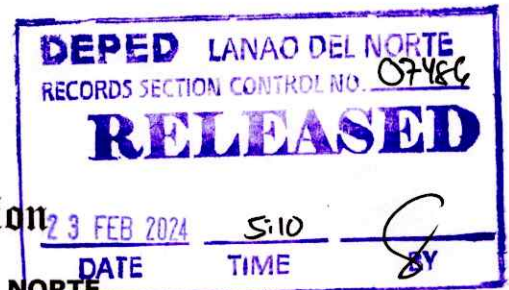

**PRECAUTIONARY MEASURES TO BE UNDERTAKEN BY SCHOOLS IN
RELATION TO THE ON-GOING ARMED CONFLICT IN SOME AREAS IN
THE PROVINCE OF LANA DEL NORTE**

1. In line with the Department of Education's commitment that is to ensure learning continuity and to protect the safety, health and well-being of learners, teaching and non-teaching personnel, this Office advises the schools from the above-mentioned districts to immediately take necessary precautionary measures from the adverse effects of the on-going armed conflict in some areas of the province.
2. Schools are directed to closely coordinate with their local authorities in all situations that will create unsafe and unsecure environment where school personnel and learners face risk of being victims.
3. In addition, schools are advised to implement learner tracking system to ensure the safety of our learners from going to school and going home. Furthermore, schools are directed to send regular updates on the school's situation through Division DRRM Coordinator.
4. For schools opting to implement other learning delivery mode such as modular, please coordinate with Curriculum Implementation Division (CID).
