PROVISION OF SUPPORT FOR FISCAL YEAR 2023 NATIONAL QUALIFYING EXAMINATION FOR SCHOOL HEADS

To: Assistant Regional Director Schools Division Superintendent Assistant Schools Division Superintendents All Others Concerned

- 1. Following DepEd Memorandum No. 013, s. 2024 titled Administration of the Fiscal Year 2023 National Qualifying Examination for School Heads (NQESH) and DepEd Memorandum No. 014, s. 2024 on Corrections and Clarifications to DepEd Memorandum 013, s. 2024, this Office will facilitate a region-wide provision of support to select NQESH examinees through the Project CELLS: Course on Executive Leadership and Learning in Schools.
- 2. Hence, the Schools Division Superintendents (SDSs) and Assistant Schools Division Superintendents (ASDSs) shall launch a division committee to provide support and guidance to NQESH qualified applicants.
- 3. The committee shall be composed of the chiefs (CID and SGOD), all district and division supervisors, and full-fledged school heads who will provide a rigorous review program and technical inputs on Philippine Professional Standards for School Heads.
- 4. A blended learning modality can be utilized, which shall commence the soonest possible time. Each session shall utilize the exploratory method and sample questions-answers-related issuances approach that can stimulate the conceptual and situational critical thinking skills of the qualified NQESH applicants.
- 5. The Structure of the Observed Learning Outcomes (SOLO) shall be used as framework aligned with the standards set by the PPSSH.



- Each SDO shall submit the list of division committee members and the timeline of implementation on March 22 for consolidation and monitoring.
- This Office directs the immediate and wide dissemination of this 7. Memorandum.
