This Region

- 1. This office, through the Quality Assurance Division (QAD) , will conduct the  $2^{nd}$ Quarter Regional Monitoring, Evaluation, and Adjustment (RMEA) scheduled tentatively on June 26-27, 2018, the venue of which will be announced later.
- 2. The aims of the CY 2018 2<sup>nd</sup> Quarter RMEA conference are as follows:
  - a. Track and assess the implementation of DepEd policies and programs in the 14 schools Divisions for the 2nd Quarter CY 2018;
  - b. Determine the efficacy and effectiveness of policy and program adjustments , if any, undertaken by the different functional divisions and units of the DepEd Regional Office X to address policy and program bottlenecks and barriers across the 14 Divisions during the 1st Quarter of CY 2018;
  - c. Determine the needed policy and program adjustments to be undertaken by the DepEd Regional Office to address performance gaps in ensuring MEA quarters CY 2018; and
  - d. Identify all other relevant steps to be undertaken by the concerned functional divisions to narrow performance gaps, thereby enabling DepEd Region X to meet its CY /SY 2022 performance targets and strategic goals.
