REITERATION OF THE IMPLEMENTATION OF THE NO COLLECTION POLICY

TO: Assistant Schools Division Superintendent
Chief Education Supervisor, SGOD

Public and Private Elementary and Secondary School Heads
This Division

1. In accordance with Republic Act (RA) No. 4206, otherwise known as *An Act of Prohibiting the Sale of Tickets and/or the Collection of Contributions for Whatever Project or Purpose from Students of Public and Private Schools, Colleges and Universities*, as amended by RA 5546 and DepEd Order (DO) No. 19, s. 2008, titled “Implementation of No Collection Policy in All Public Elementary and Secondary Schools”, this Office reiterates that the collection of contributions in any form whatsoever from school children, students, and teachers is prohibited, pursuant to RA 4206 as amended by RA 5546, thus:

Section 1. The sale of tickets and/or the collection of contributions in any form whatsoever, by any person for any project or purpose, whether voluntary or otherwise, from school children, students and teachers of public and private schools, colleges, and universities is hereby prohibited: Provided, however, that this prohibition shall not cover membership fees of school children and students in the Red Cross, the Girl Scouts of the Philippines, and the Boy Scouts of the Philippines: Provided, finally, that this Prohibition shall not cover the contributions of parents and other donors for the support of barrio high schools.

SUBJECT : **REITERATION OF THE IMPLEMENTATION OF THE NO COLLECTION POLICY IN ALL PUBLIC SCHOOLS**

DATE :

1. In accordance with Republic Act (RA) No. 4206, otherwise known as An Act Prohibiting the Sale of Tickets and/or the Collection of Contributions for Whatever Project or Purpose from Students and Teachers of Public and Private Schools, Colleges and Universities, as amended by RA 5546, the Department of Education (DepEd) issued DepEd Order (DO) No. 19, s. 2008, titled "Implementation of No Collection Policy in All Public Elementary and Secondary Schools." This Order prohibits the collection of fees from learners during enrollment and at any time during the school year.

2. Pursuant to RA 4206, as amended by RA 5546, the collection of contributions in any form whatsoever from school children, students, and teachers is prohibited, thus:

Section 1. The **sale of tickets and/or the collection of contributions in any form whatsoever**, by any person for any project or purpose, **whether voluntary or otherwise**, from **school children, students and teachers** of public and private schools, colleges and universities is hereby prohibited: Provided, however, That this prohibition shall not cover membership fees of school children and students in the Red Cross, the girl scouts of the Philippines and the boy scouts of the Philippines: Provided, finally, That this Prohibition shall not cover the contributions of parents and other donors for the support of barrio high schools (Emphasis supplied).

3. In this regard, the Department reiterates that the **sale of raffle tickets and the collection of funds in any form**, for the conduct of programs, beauty pageants, events, ceremonies, and other similar activities, from the abovementioned individuals shall be strictly prohibited.
