1. Pursuant to DepEd Order No. 009, s. 2021 titled ***Institutionalization of the Quality Management System (QMS) in the Department of Education***, this Office reiterates the instruction to recite the DepEd Quality Policy Statement (QPS) as disseminated in Memorandum DM-OUHROD-2023-0074.
2. The QPS is the articulation of DepEd's commitment to implement the National QMS in accordance with the agency's mandate, vision, mission, and core values and an embodiment of the overall intention and direction of DepEd's commitment to deliver quality services.
3. The QPS must be recited by teaching and non-teaching personnel during Flag Ceremony and shall be included in the preliminary activities during the conduct of trainings, seminars, workshops, and other similar activities of the Division Office. For the schools, it shall be recited during the preliminary activities of faculty meetings, learning action cell sessions, and any other similar activities.
4. Division Office and school personnel are also required to post a copy of the QPS within their office premises and websites, and use it as screen background/wallpaper of every DepEd-owned laptop/desktop.
