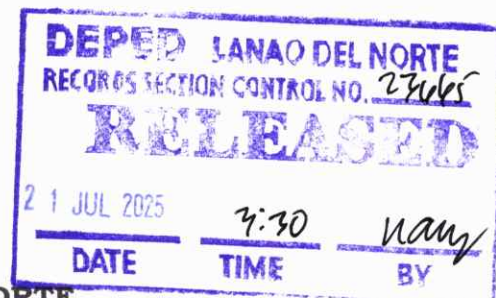

**SHARPENING THE LENS: CLUSTERED DISTRICT ORIENTATION ON
TRANSFORMATIVE INSTRUCTIONAL SUPERVISION**

1. In line with the Department of Education's commitment to ensuring quality and relevant education through strengthened instructional leadership, this Office announces the conduct of a Clustered District Orientation on Transformative Instructional Supervision to equip school heads with effective, learner-centered, and reflective supervision practices on July 23, 2025.
2. This initiative aims to recalibrate the lens of instructional supervision, shifting focus from compliance-based monitoring to transformative and supportive supervision that empowers teachers, improves instructional delivery and uplifts learning outcomes.
3. The objectives of this activity are:
 - a. Deepen understanding of transformative instructional supervision anchored on quality learning and teaching;
 - b. Equip school heads with practical tools and strategies for effective classroom observation, mentoring and coaching;
 - c. Foster reflective practices aligned with DepEd's instructional supervision framework;
 - d. Establish a collaborative platform among school heads for sharing best practices and addressing supervision challenges.
