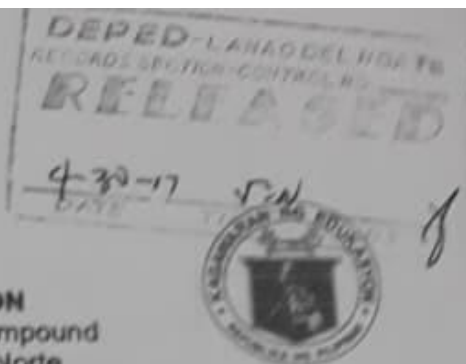




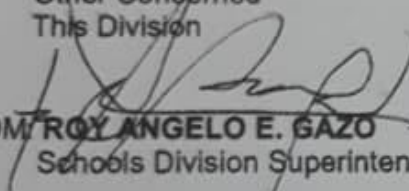

5. Immediate dissemination and strict compliance with this Memorandum to all concerned is highly enjoined.



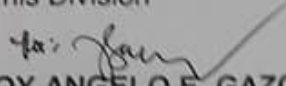

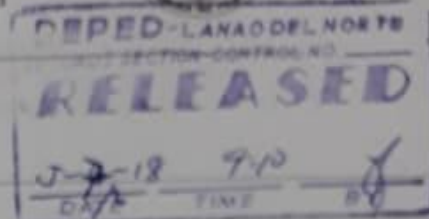

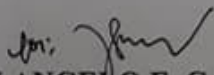
