## SUBMISSION OF SCHOOL'S CASH IN BANK REGISTER (CBR) TOGETHER WITH SUPPORTING DOCUMENTS FOR FISCAL YEAR 2023

To:

Public Elementary and Secondary School Heads (Non-Ius)

Non-IUS, Senior Bookkeepers

All Others Concerned

- 1. Relative to the Letter of Authority received by the Division Office dated April 15, 2025, from Bureau of Internal Revenue authorizing the Revenue Officer of RDO No. 101-Iligan City to examine the books of accounts and other accounting records of this Division for the period from January 1, 2023 to December 31, 2023, this Office hereby requires all School Heads and Senior Bookkeepers to submit the Cash in Bank Register (CBR) for the fiscal year 2023 of their respective school/s together with the photocopy of the following required documents:
  - a. Disbursement Vouchers of all transactions
  - b. Bills and Statements of Accounts (utility bills, payment notices, etc.)
  - c. Contracts (purchase order)
  - d. Invoices (sales, purchases and charge invoices)
  - e. Certificate of Taxes Withheld (BIR Form 2306 & 2307)
- Upon completion of the documents, all senior bookkeepers are directed to transmit the files to the Accounting Unit on or before May 05, 2025, for the review and final compilation of all records by the Accounting Unit before submitting to the BIR-RDO 101-Iligan City on May 09, 2025.
- 3. Failure of the School Heads to submit the required documents shall be considered as personal liability equivalent to the total amount of the tax not withheld, or not accounted for and remitted without prejudice to the other penalties provided for under the National Internal Revenue Code.
