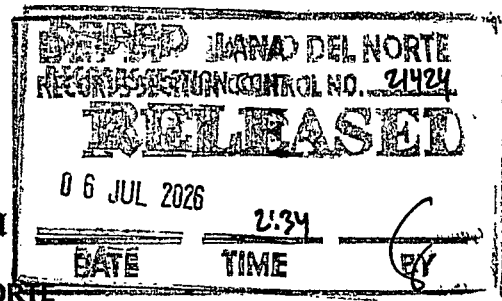

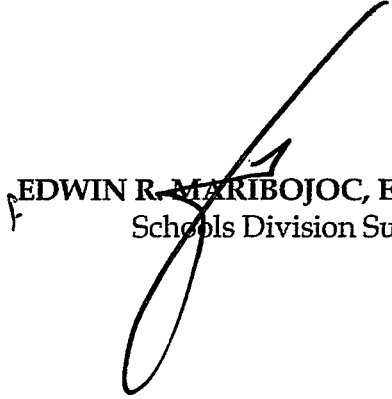
5. The DTWG and resource speaker shall be accommodated at Kauswagan Organic International Convention Center while training participants shall be housed at Kauswagan Central Elementary School.

6. To ensure engaged Time-On-Task per DepEd Order No. 9 s 2005, teacher-coaches and DTWG members shall submit an instructional plan for July 24, 2026 for school heads to monitor and head teachers to attend to.

7. Travel, meals, and incidental expenses incurred during the conduct of the activity shall be charged to local funds subject to the usual accounting rules and procedures.

8. Service credits shall be given to teachers while CTO shall be credited to non-teaching personnel for every weekend attendance, per DepEd Order No. 53 s. 2003, only upon submission of two copies of accomplished Form 48.
