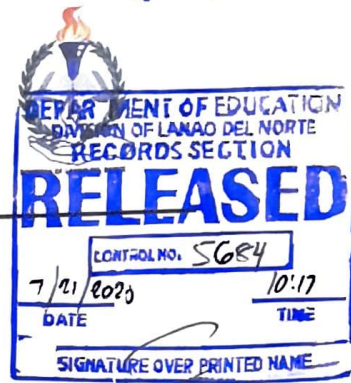








SUBJECT: *Virtual Research O'clock on Learning Continuity*

DATE: June 29, 2020

Since 2018, the Department of Education (DepEd) through the Planning Service - Policy Research and Development Division has been conducting Research O'clock, a research dissemination forum that aims to promote the use of research results and evidence in decision-making, program designing and implementation, and plan formulation and adjustment in the basic education sector. This research forum has been convening educators, researchers, program implementers, and policymakers to discuss education issues and provide valuable inputs for future relevant actions. The forum also serves as a venue for policy feedback from field implementers.

Last February, DepEd Memorandum 24, s. 2020 was issued which lays down the Research O'clock themes and topics which were aligned to support the directives of the *SulongEduKalidad*, a national campaign that aims to consolidate the efforts of all stakeholders to raise the quality of basic education in the country.

However, with the COVID-19 pandemic, the Department faces the challenge of ensuring continuity of learning during this public health emergency. As a response, the Department developed the Basic Education - Learning Continuity Plan (BE-LCP) which lays down systematic and collaborative strategies to address the effects of the COVID-19 pandemic to basic education.

In support of the implementation of the BE-LCP, a *Virtual Research O'clock* will be conducted in July and August 2020 where presentations are focused on the principles of continuing education in emergencies while sustaining the quality of learning delivery. The *Virtual Research O'clock* aims
